

TESTIMONY OF MAJOR GENERAL ALAN S. DOHRMANN NORTH DAKOTA NATIONAL GUARD BEFORE THE SENATE APPROPRIATIONS COMMITTEE 13 JANUARY 2023 SENATE BILL 2025

Good morning Mr. Chairman, members of the committee, I am Al Dohrmann, Adjutant General and Director of Emergency Services for the state of North Dakota. I am here today to testify in support of Subdivision 7 of Senate Bill 2025.

Subdivision 7 provides \$14,556,524 of loan authority from the Bank of North Dakota (BND). I would like to provide updated estimates for the loans we have outstanding. We are asking for \$4,695,890 for projected disaster and fire related cost this biennium, and \$14,342,620 of BND loan authority to pay the remaining balance of the Dakota Access Pipeline protest loans with BND. The sum of these two loan repayments is now \$19,038,510. I will address the DAPL loan and will bring Mr. Hanson, our Director of Homeland Security, up to provide an update on the disaster costs.

Attachment #1 provides a breakdown of the DAPL cost and the payments made against loans totaling \$39,342,620 dating back to the Fall of 2016. As you can see, we have received \$10,000,000 of federal funds from a Department of Justice Emergency Law Enforcement Assistance Grant, along with \$15,000,000 of donations to pay down the principle, leaving us with \$14,342,620 in our deficiency. This amount is comprised of \$13,362,262 in principle and an estimated \$980,358 in interest through June 30, 2023. In previous bienniums, \$1,531,173 in interest has been paid on the outstanding loans, including \$703,432 in last biennium. When including projected interest from the current biennium, the total interest accrued is \$2,511,531.

Also, within Subdivision 7 is \$4,695,890 for the state cost share related to wildfire response and presidentially declared disasters, including the 2021 summer storm (DR4613), the 2022 spring storm (DR4660), and the hazard mitigation grant program made available from the COVID-19 event (DR4509).

With that Mr. Chairman, I will turn it over to Darin to provide an update on the remaining disaster declarations.

Good morning, Mr. Chairman, and members of the committee. I am Darin Hanson, Director of Homeland Security at the Department of Emergency Services. I would like to provide an update on the two storm disasters declared this biennium, along with the loan authority for fire response and hazard mitigation dollars linked to COVID-19.

Beginning on Attachment #2 with the wildfire response, we are asking for \$971,074 to repay principal and interest on a BND loan draw. The wildfire response costs are primarily related to the 2021 fire season and were made available under an emergency clause within the agency's 2021-2023 appropriation bill (HB 1016) in the amount of \$2.5 million. The vast majority of those funds were used for ground and aerial fire suppression performed through both State Active Duty response, as well as response efforts from the

ND Forest Service. The remainder of the appropriation is not expected to be used. Next, we are seeking reimbursement for the state share of the hazard mitigation grant program made available by the COVID-19 event in the amount of \$22,153.

Moving to Attachment #3, there are two storm disasters incurred this biennium. These two disasters involved 40 counties throughout the state with an estimated state cost share of \$3,702,663 to be paid out this biennium. The first storm was the 2021 Summer Storms which resulted in a \$100,209 state share of response and recovery costs. The second storm was the 2022 Spring Storms, causing an estimated \$97 million in total damages and resulting in an estimated state share of disbursed response and recovery funds this biennium of \$3,602,454.

In conclusion, Mr. Chairman, we are requesting a total of \$4,695,890 for the estimated state share of disbursed costs for disaster response, recovery, and mitigation programs. The items identified within Subdivision 7 are estimates and any excess funding will not be expended.

We ask for your support of SB 2025 and will stand by for any questions you may have.

TESTIMONY OF

Joe Morrissette, Director, Office of Management and Budget

Good morning, Chairman Bekkedahl and members of the Senate Appropriations committee. I am Joe Morrissette, the Director of the Office of Management and Budget (OMB) and I am here to ask your support for the deficiency appropriation bill, SB 2025.

The information contained in this bill matches the deficiency appropriation requests known to OMB at the time the executive budget was finalized. Since that time, additional information has become available, and I will be asking you to consider an amendment to the bill as drafted.

I will provide a brief overview of each request. Representatives from each agency are here to provide additional detail or answer specific questions.

Office of Management and Budget

The appropriation in subdivision 1 is to pay the court-ordered judgement in the case of Hendrix, et al. v. Jaeger, relating to an initiated measure for term limits. The judgement of \$765 was entered on Sept. 19, 2022.

I ask that you to amend this amount to \$277,771, an increase of \$277,006. This increase is to pay the court-ordered judgement, plus accrued interest, in the case of Northwest Landowners Association v. State of North Dakota, relating to pore space rights. The judgement of \$265,767.32 was entered on October 7, 2022. With interest accrued through the end of May 2023, the amount required to pay the total judgement plus accrued interest is estimated to be \$277,006.

Attorney General

The appropriation of \$75,000 in subdivision 2 is to cover costs to reimbursement to counties for prosecution witness fees. The original appropriation for this purpose is \$95,000 and \$111,257 has been spent through Dec. 31.

Ethics Commission

The appropriation of \$97,000 in subdivision 3 is to cover the following estimated costs:

- \$72,000 for the services of a special assistant attorney general (SAAG).
- \$25,000 for estimated office relocation and renovation costs.

University of North Dakota

The appropriation of \$430,101 in subdivision 4 is to reimburse the University of North Dakota for unrecovered payments made to a fraudulent bank account, which resulted in the invoice being paid twice and shortfall of that amount for the university's 2021-23 budget.

Dakota College at Bottineau

The appropriation of \$99,768 in subdivision 5 is to reimburse Dakota College at Bottineau for expenses incurred for the College Ready English and Math program. This reimbursement was intended to come from the Department of Public Instruction (DPI) during the 2021-23 biennium. However, the claim for reimbursement was made after July 1, 2021, at which time the DPI appropriation was no longer available.

Department of Health and Human Services (DHHS)

The appropriation of \$310 million in subdivision 6 is to cover the additional 6.2% in Federal Medical Assistance Percentage (FMAP) reimbursement during the public health emergency (PHE). A requirement of receiving the additional 6.2% is to maintain current enrollment in the program and not remove anyone from the Medicaid roles despite eligibility changes. The additional 6.2% FMAP results in an overall general fund savings. However, Section 7 of 2021 HB 1012 prohibits the DHHS from spending the general fund savings during this biennium. Offsetting the requested general fund appropriation of \$25 million in this bill is expected general fund turnback of \$120 million.

Adjutant General

The appropriation of \$14.6 million in subdivision 7 is to cover the cost of loans from the Bank of North Dakota for the state response to the Dakota Access Pipeline (DAPL) protest in the amount of \$13,362,262, and various other disaster costs in the amount of \$904,203. Representatives of the Office of the Adjutant General and the Department of Emergency Services are here to ask for an amendment to these amounts: \$14,342,620 for DAPL loan repayment and \$4,695,890 for disaster response costs.



TESTIMONY OF MAJOR GENERAL ALAN S. DOHRMANN NORTH DAKOTA NATIONAL GUARD BEFORE THE HOUSE APPROPRIATIONS COMMITTEE 13 MARCH 2023 SENATE BILL 2025

Good morning Mr. Chairman, members of the committee, I am Al Dohrmann, Adjutant General and Director of Emergency Services for the state of North Dakota. I am here today to testify in support of Subdivision 6 of Senate Bill 2025.

Subdivision 6 provides \$14,556,524 of loan authority from the Bank of North Dakota (BND). I would like to provide updated estimates for the loans we have outstanding. We are asking for \$4,695,890 for projected disaster and fire related cost this biennium, and \$14,355,095 of BND loan authority to pay the remaining balance of the Dakota Access Pipeline protest loans with BND. The sum of these two loan repayments is now \$19,050,985. I will address the DAPL loan and will bring Mr. Hanson, our Director of Homeland Security, up to provide an update on the disaster costs.

Attachment #1 provides a breakdown of the DAPL cost and the payments made against loans totaling \$39,355,095 dating back to the Fall of 2016. As you can see, we have received \$10,000,000 of federal funds from a Department of Justice Emergency Law Enforcement Assistance Grant, along with \$15,000,000 of donations to pay down the principle, leaving us with \$14,355,095 in our deficiency. This amount is comprised of \$13,362,262 in principle and an estimated \$992,833 in interest through June 30, 2023. In previous bienniums, \$1,531,173 in interest has been paid on the outstanding loans, including \$703,432 in last biennium. When including projected interest from the current biennium, the total interest accrued is \$2,524,007.

Also, within Subdivision 6 is \$4,695,890 for the state cost share related to wildfire response and presidentially declared disasters, including the 2021 summer storm (DR4613), the 2022 spring storm (DR4660), and the hazard mitigation grant program made available from the COVID-19 event (DR4509).

With that Mr. Chairman, I will turn it over to Darin to provide an update on the remaining disaster declarations.

Good morning, Mr. Chairman, and members of the committee. I am Darin Hanson, Director of Homeland Security at the Department of Emergency Services. I would like to provide an update on the two storm disasters declared this biennium, along with the loan authority for fire response and hazard mitigation dollars linked to COVID-19.

Beginning on Attachment #2 with the wildfire response, we are asking for \$971,074 to repay principal and interest on a BND loan draw. The wildfire response costs are primarily related to the 2021 fire season and were made available under an emergency clause within the agency's 2021-2023 appropriation bill (HB 1016) in the amount of \$2.5 million. The vast majority of those funds were used for ground and aerial fire suppression performed through both State Active Duty response, as well as response efforts from the

ND Forest Service. The remainder of the appropriation is not expected to be used. Next, we are seeking reimbursement for the state share of the hazard mitigation grant program made available by the COVID-19 event in the amount of \$22,153.

Moving to Attachment #3, there are two storm disasters incurred this biennium. These two disasters involved 40 counties throughout the state with an estimated state cost share of \$3,702,663 to be paid out this biennium. The first storm was the 2021 Summer Storms which resulted in a \$100,209 state share of response and recovery costs. The second storm was the 2022 Spring Storms, causing an estimated \$97 million in total damages and resulting in an estimated state share of disbursed response and recovery funds this biennium of \$3,602,454.

In conclusion, Mr. Chairman, we are requesting a total of \$4,695,890 for the estimated state share of disbursed costs for disaster response, recovery, and mitigation programs. The items identified within Subdivision 6 are estimates and any excess funding will not be expended.

We ask for your support of SB 2025 and will stand by for any questions you may have.

North Dakota Ethics Commission Senate Bill 2025 Testimony presented by Executive Director, Rebecca Binstock Before the House Appropriations Committee March 13, 2023

Good morning, Mr. Chairman and Committee members, my name is Rebecca Binstock. I serve as the Executive Director of the North Dakota Ethics Commission.

Most recently, there has been an increase in the level of activity with the Ethics Commission:

- In 2022, there were 14 complaints filed with the Commission, compared to 9 complaints filed in 2021, 3 complaints in 2020, and 2 complaints in 2019. To date in 2023, the Commission has had two (2) complaints filed. The Commission has 11 pending complaints as of March 13, 2023.
- Meeting notice forms filed with the Commission exponentially increased near the end of 2022. To date, in 2023, we have had 55 meeting notices filed. The Commission anticipates level of activity will be sustained through the remainder of this biennium.
- With the adoption of gift rules, quasi-judicial bias rules, and conflict of interest rules, the Commission has increased education to those individuals subject to the rules. Part of this educational component includes providing guidance to other agencies, commissions, and boards on how to integrate policies and procedures with adopted rules.
- The Commission's activity statistics are attached (Attachment No. 1).

The 2021-23 biennial budget for the Ethics Commission is \$623,984 in general funds. As of January 31, 2023, the Commission has spent \$466,085 leaving a remaining balance for the biennium of \$157,899 (Attachment No. 2). The Commission projects the remaining \$157,899 will not cover projected expenditures of the biennium. The Commission is requesting a deficiency appropriation of \$97,000 to cover expenditures.

The increase in activity has led to significant budgetary challenges for the Commission:

- 1. An overall increase in temporary staff hours and an increase in special meetings.
- The Commission anticipates a continual steady increase in activity and travel as additional rules are implemented and the Commission provides education to those impacted by rules.

- 3. The Ethics Commission had to hire a Special Assistant Attorney General (SAAG) in November of 2022 to address nine (9) complaints that have been filed with the Commission due to the recusal of the Office of the Attorney General.
- 4. Anticipation of remodel costs (to ensure separation from other agencies) for relocation of the office to the capitol in the Summer of 2023.

The Commission has worked to offset the increased costs in several ways:

- The Commission vacated its office space in November 2022, in hopes of finding a space within the capitol in the upcoming months.
- The Commission has continued to limit its in-person meetings and reduce travel.
- The Commission did not attend the annual COGEL (Council on Governmental Ethics Laws) conference.

With these off-sets, the Commission has been able to fund the cost of increased temporary staff hours and special meetings, along with other operational costs. However, the off-sets and savings the Commission was able to make (with an already lean budget) do not provide enough funding to cover the \$72,000 cost of hiring a SAAG for Complaints (as well as other investigation costs) through June 30, 2023, and \$25,000 in estimated office relocation costs.

In light of the above, the Ethics Commission is requesting a deficiency appropriation of \$97,000, which consists of \$72,000 in Special Assistant Attorney General ("SAAG") costs and \$25,000 in remodel costs.

Pursuant to N.D.C.C. § 54-66-14, the Office of the Attorney General is to provide legal services to the Commission. However, this past year, the Commission hired attorney Patricia Monson (Fargo) to serve as SAAG to advise the Commission as to Complaint Nos. 22-003 through 22-010 and 22-012, from which the Office of the Attorney General recused. The \$72,000 requested is based on a cost of \$9,000 per month for SAAG costs for the remainder of the biennium. This amount may also cover potential additional investigation costs. This estimate does not include any additional costs the Commission may incur if it needs to retain a SAAG for additional complaints during this biennium.

The Commission has estimated remodel costs of an office space within the capitol at \$75,000 to ensure secure access to the space and sufficient privacy, including NDIT line and equipment installation and furniture. This estimate is based on recently completed projects and estimates for similar projects as provided by John Boyle with OMB. However, the Commission is only requesting \$25,000 for a potential move-in date of June 1, 2023, with the remaining \$50,000 being covered by OMB's facilities improvement budget to be available July 1, 2023.

The Commission is also requesting an amendment to SB 2025 to carry over the \$97,000 as the Commission is unsure 100% of expenditures will be incurred for these two items by June 30, 2023. (Attachment No. 3).

Testimony in Support of Senate Bill No. 2025 Senate Appropriations January 13, 2023

TESTIMONY OF

Joe Morrissette, Director, Office of Management and Budget

Good morning, Chairman Bekkedahl and members of the Senate Appropriations committee. I am Joe Morrissette, the Director of the Office of Management and Budget (OMB) and I am here to ask your support for the deficiency appropriation bill, SB 2025.

The information contained in this bill matches the deficiency appropriation requests known to OMB at the time the executive budget was finalized. Since that time, additional information has become available, and I will be asking you to consider an amendment to the bill as drafted.

I will provide a brief overview of each request. Representatives from each agency are here to provide additional detail or answer specific questions.

Office of Management and Budget

The appropriation in subdivision 1 is to pay the court-ordered judgement in the case of Hendrix, et al. v. Jaeger, relating to an initiated measure for term limits. The judgement of \$765 was entered on Sept. 19, 2022.

I ask that you to amend this amount to \$277,771, an increase of \$277,006. This increase is to pay the court-ordered judgement, plus accrued interest, in the case of Northwest Landowners Association v. State of North Dakota, relating to pore space rights. The judgement of \$265,767.32 was entered on October 7, 2022. With interest accrued through the end of May 2023, the amount required to pay the total judgement plus accrued interest is estimated to be \$277,006.

Attorney General

The appropriation of \$75,000 in subdivision 2 is to cover costs to reimbursement to counties for prosecution witness fees. The original appropriation for this purpose is \$95,000 and \$111,257 has been spent through Dec. 31.

Ethics Commission

The appropriation of \$97,000 in subdivision 3 is to cover the following estimated costs:

- \$72,000 for the services of a special assistant attorney general (SAAG).
- \$25,000 for estimated office relocation and renovation costs.

University of North Dakota

The appropriation of \$430,101 in subdivision 4 is to reimburse the University of North Dakota for unrecovered payments made to a fraudulent bank account, which resulted in the invoice being paid twice and shortfall of that amount for the university's 2021-23 budget.

Dakota College at Bottineau

The appropriation of \$99,768 in subdivision 5 is to reimburse Dakota College at Bottineau for expenses incurred for the College Ready English and Math program. This reimbursement was intended to come from the Department of Public Instruction (DPI) during the 2021-23 biennium. However, the claim for reimbursement was made after July 1, 2021, at which time the DPI appropriation was no longer available.

Department of Health and Human Services (DHHS)

The appropriation of \$310 million in subdivision 6 is to cover the additional 6.2% in Federal Medical Assistance Percentage (FMAP) reimbursement during the public health emergency (PHE). A requirement of receiving the additional 6.2% is to maintain current enrollment in the program and not remove anyone from the Medicaid roles despite eligibility changes. The additional 6.2% FMAP results in an overall general fund savings. However, Section 7 of 2021 HB 1012 prohibits the DHHS from spending the general fund savings during this biennium. Offsetting the requested general fund appropriation of \$25 million in this bill is expected general fund turnback of \$120 million.

Adjutant General

The appropriation of \$14.6 million in subdivision 7 is to cover the cost of loans from the Bank of North Dakota for the state response to the Dakota Access Pipeline (DAPL) protest in the amount of \$13,362,262, and various other disaster costs in the amount of \$904,203. Representatives of the Office of the Adjutant General and the Department of Emergency Services are here to ask for an amendment to these amounts: \$14,342,620 for DAPL loan repayment and \$4,695,890 for disaster response costs.

Agriculture Commission

The appropriation of \$1.7 million in subdivision 8 is to repay a loan at the Bank of North Dakota for the Emergency Feed Transportation Assistance Program.

- · Removes the \$97,000 general fund appropriation for the Ethics Commission;
