Senate Bill 2145 Testimony Senator Kyle Davison January 16th, 2023

Good Morning, I'm Senator Kyle Davison from District 41 representing south Fargo. I'm here today to support an innovative workforce training program that doesn't quite fit into the normal structure of CTE in ND.

The Emerging Digital Academy (EDA) started in 2019 and it operates a 20-week software development program that teaches not only the concepts of coding and software design, but how to build modern apps.

Because EDA offers workforce training, it's regulated under the umbrella of the CTE board of North Dakota. The CTE board's rules don't mesh with a coding school bootcamp like EDA because the rules requiring accreditation. Accreditation of coding schools doesn't make sense because the standards of what is being taught changes so rapidly.

That is why SB 2145 seeks to exempt the coding school from having to get accredited. EDA will still need to get licensed by CTE, which has a lot of benefits—including access to student financial aid—but they won't need to be accredited.

The leaders of EDA are here today to offer any detailed information you may find useful. Additionally, in working with CTE leadership, they will be offering a friendly amendment that I support and I know EDA supports. Thank you to them for making this bill better.

I'd ask for your support of SB 2145, which will help modernize the regulation of workforce training for coding bootcamps.

Senate Education SB2145

January 16, 2022

Chairman Elkin and members of the Senate Education Committee, my name is Wayde Sick, State Director for the Department of Career and Technical Education. I am here to testify in support of SB2145, with proposed amendments.

The State Board for Career and Technical Education has the authority to approve the operations of Postsecondary Career Schools. The reason for this authority is to provide oversight over the operations and to ensure the students enrolling in these programs are protected. They are assured the training they receive is high quality, they have the option to receive refunds, if not satisfied with the training, and there is a process for complaints. Examples of approved Postsecondary Career Schools include Lynnes Welding and Emerging Digital Academy. A requirement, as defined in century code, is to be nationally or regionally credentialed. The reason for this is to assure the content is of high quality and that the program is legitimate and reputable.

SB2145 is an attempt to allow the State Board for Career and Technical Education the ability to exempt an organization that is offering a full-stack software engineering course that was in operation before 2020. This is specifically Emerging Digital Academy (EDA). EDA has been provisionally approved to operate in the state as they have been working with a national accreditor. Statute allows EDA to operate provisionally, as long as they are in good-faith, making progress towards national accreditation.

According to EDA, due to its unique content, they are having difficulty becoming nationally accredited. SB2145, as written, would exempt them from needing to be nationally accredited to operate in the state, but would not allow a similar organization the same exemption.

The Department proposes the following amendments.

Page 1, line 2, remove the period and insert immediately after "to provide for a legislative management study; to provide an expiration date; and to declare an emergency."

Page 2, line 4, insert the following:

"SECTION 2. LEGISLATIVE MANAGEMENT STUDY - (POSTSECONDARY CAREER SCHOOL AUTHORIZATION). During the 2023-24 interim, the legislative management shall consider studying the statute for the authorization to operate postsecondary career schools. The legislative management shall report its findings and recommendations, together with any legislation necessary to implement the recommendations, to the sixty-ninth legislative assembly.

This study would allow the state to study the current statute, to determine if there are necessary changes, that will provide schools flexibility, while ensuring student confidence.

SECTION 3. EXPIRATION DATE. This Act is effective through January 1, 2026, and after that date is ineffective.

The expiration date would end EDA's authority to operate under current statute, requiring all providers, current and future, to follow new statute, however, allowing the Board time to draft any administrative rules necessary after the 69th legislative session.

SECTION 4. EMERGENCY. Section 1 of this Act is declared to be an emergency measure."

This allows EDA to operate in the upcoming year, as all Postsecondary Career School are required to request reapproval to operate every year. EDA's approval expires June 30, 2023. This law, without an emergency clause, will not take effect until August 1, 2023, so EDA would have to go through the reapproval process with the Board again.



This study would advise the State Board for Career and Technical Education and the 69th Legislative Assembly of any necessary changes to statute. EDA would then need to follow any changes to the approval process.

SB2145 also includes an emergency clause. This allows EDA to operate in the upcoming year, as all Postsecondary Career Schools are required to request reapproval to operate every year. EDA's approval expires June 30, 2023. This bill if passed, without an emergency clause, will not take effect until August 1, 2023, so EDA would have to go through the reapproval process with the Board again.

We have been working in cooperation with the CTE board since the first Authorization to Operate A Private Career School application was submitted by our team in January 2020. Over





the past 3 years, we have successfully gained provisional licensure status each year, and worked in good faith with the CTE board to understand the constraints and exemptions from the accreditation requirement in the NDCC.

While we have had ongoing discussion during each annual renewal cycle with the CTE board about this requirement, we began looking to implement a fix in the North Dakota Century Code in fall 2021. In Spring 2022 we explored the current law to understand if the existing language allowed for accreditation exemptions but after working with the CTE board it was determined that an update to NDCC was the best course of action.

EDA currently operates with a provisional license to operate which is authorized by CTE, which is intended as a temporary approval for new programs. Obtaining a full license to operate will provide clarity and certainty for the program. Achieving a full license to operate is the ultimate goal of career training programs licensed by CTE to operate in the State of North Dakota.

There are several state systems that require licensure to operate such as the Bank of North Dakota, Career Builders, and Job Services as well as several federal programs such as veteran skill training opportunities. Achieving full licensure beyond provisional status is the ultimate goal to ensure that EDA is maintaining the highest standards of quality and can continue to work with these various systems and programs at the state and federal level long term.

SB 2145 adds an additional condition for exemption to the section that requires accreditation to move from provisional to full operating license. This exemption will allow EDA to operate under a full license as authorized by the CTE board.
