# PROPOSED AMENDMENTS TO SENATE BILL NO. 2289

Page 2, line 3, after "...programs." add "<u>The committee shall develop an understanding of the</u> <u>financial burden of plugging and reclaiming oil locations to prevent a possible burden</u> to the state's taxpayers and landowners."

Page 2, line 6, after "...marketing," replace "distribution, and use of energy" with "distribution, use of energy and retirement of wells including plugging and reclamation."

Page 2, line 6, after "...energy." add a new section 2:

"SECTION 2. LEGISLATIVE MANAGEMENT STUDY – CONSIDERATION OF REGULATORY MODELS FOR ADDRESSING ORPHANED AND ABANDONED WELL RECLAMATION

In conjunction with development of this policy, during the 2023-24 interim, the Legislative Management shall study regulatory mechanisms used in other states in the United States of America and those used in Canada to address the reclamation of orphaned and abandoned oil and gas wells, including but not limited to regulations addressing transfers of wells between operators, bonding and bonding amounts, use of temporary abandonment status, taxpayer funded mechanisms such as the Federal CARES Act or Abandoned Well Fund, and other ways to address reclamation of orphaned and abandoned oil and gas wells before they become the liability of the State of North Dakota and its landowners. Testimony of Troy Coons on behalf of Northwest Landowners Association in favor of SENATE BILL NO. 2289 Senate Energy and Natural Resources Committee February 2, 2023

Chairman Patten and members of the committee, thank you for taking my testimony into consideration today.

My name is Troy Coons and I am the Chairman of the Northwest Landowners Association. Northwest Landowners Association represents over 525 farmers, ranchers, and property owners in North Dakota. Northwest Landowners Association is a nonprofit organization, and I am not a paid lobbyist.

We support SB 2289 and agree that it is wise to consider a comprehensive statewide energy policy. We also appreciate that the language of this bill recognizes the importance of "developing synergy between energy and agriculture programs." Toward that end, we have continually raised the alarm regarding the looming problem of orphaned and abandoned wells in our oilfields. This is a major concern for landowners because North Dakota is a less mature oilfield. This is a problem that every major oil producing government in North America has faced, and we are one of the first states that has the ability to get out ahead of the problem. Our regulators are asking you to take a wait and see approach, but we are trying to raise the alarm that the wait and see attitude is exactly what regulators in other jurisdictions have warned everyone will always fail. We would ask that this committee amend the current language of SB 2289 to add in our request for a study of the issue of abandoned wells and how other jurisdictions have addressed the issue, with the goal of getting out ahead of this problem so that it is not a problem in the end for the landowners and the taxpayers.

The language of the draft amendment would take the first step in ensuring that North Dakota does not make the mistakes that other oil producing jurisdictions have made by taking a wait and see approach. We support SB 2289 and request a do pass along with the proposed amendment.
