Chairman Luick and members of the Senate Agriculture and Veterans Affairs Committee, I am Agriculture Commissioner Doug Goehring. Thank you for the opportunity to appear before the committee. I am here today in support of Senate Bill 2290, which would provide funding for the Grassland Grazing Cost Share Program. The funding would be used for water development, fencing, conservation initiatives, compliance with federal permitting requirements, and projects that enhance wildlife habitat, increasing soil health, and enhancing the health grasslands.

The North Dakota Department of Agriculture is currently administering the cost share program for the 21-23 biennium and has identified that there still exists a significant need for additional funding. Due to the increase in costs, supply chain issues and a lag in the federal governments review process. The bill would also

Report on 1st round Grasslands Grazing Grant funding.

To date, **29** projects have been completely installed & finalized (reimbursement has been received from ND Dept. of Ag.). Below amounts refer only to these 29 projects:

- Total project costs: \$881,860.
- Total project costs shortfall: \$136,848.
- The average member cost share: 34%
- No member paid less than 25% cost share & this applied to only 12 projects.
- The remaining 17 projects had member cost share ranging from 59% to 27%.

This funding was used to install the following:

- 109,379 feet of pipeline
- 1 water well
- 22 livestock water tanks
- 19 dams (cleanouts/repairs/digging new dams)
- 18,125 feet of fence



Allot #201 Tank

<u>Proposed project</u>: The MGA plans to install approximately 10 miles of pipeline off this converted well. This pipeline will feed approximately 18 to 20 more livestock water tanks which will serve 5 different Allotments and 6 different MGA members, with potentially 1 more member added at a later stage. This will provide water to, on average, 1,200 head of cattle.

The Medora Grazing Association was started back in the thirties, there was not a lot of assistance at that time for the ranching community. You had to do with what you had to keep food on your table and feed your livestock.

We relied on mother nature to grow the grass, fill the water holes for our livestock.

Times have changed and there are programs/ funding for other industries for them to produce products for the state as well as the country. Ranching has been at the bottom of the pile.

With this Bill and funding in the last year has given some light, with shared funding, ranchers are able to improve their places, as well as the state and federal allotments for the cattle, to utilize areas of grass where there has been no water source, by spreading out the water cows and wildlife graze areas not used, which in turn rejuvenates grasses.

Areas that need new fencing to hold the cow on that grass, this in turn will give them a better quality of livestock to sell.

The ability to put in a pipeline and tanks, fences will help the future generations as they build up their operations and cow herds.

One other thing to think about is that these new water sources will also be utilized by bikers, trail riders and hikers, a water source out in the back county around Medora would certainly get utilized by wildlife as well tourist visiting the area. Hunters would also utilize these water sources. I have experienced many rescues on the Maada Hey trail over the years, many of these rescues were due to dehydration, with these water tanks available on public lands it will benefit these types of incidents from happening as often.

In the event of a grasslands fire, one of these 1200-gallon tanks would fill a slip-on truck two to four times, right there on site.

This water improvement project over the last year has provided a reliable water source to areas that desperately needed improvement. Getting this water to our grazing areas will improve the quality of livestock, the grasslands and help to improve the Forest Service's public lands for future generations. I have meet with several permittees and they feel this is a step forward improving their Ranches.

Attachment A Updated June 2017

The following is a brief response to your questions regarding the management of federal land payments in North Dakota. The State Treasurer's website provides current (and some historical data) about allocations that pass through the State.

Forest Reserve Receipts: This revenue is paid to the State for total distribution to the counties. Although this revenue is to be used for schools and local roads, only one county (McHenry) receives revenue and the amount is so small (\$315 in FFY2016), it has been reported that they deposit it into the county general fund.

Taylor-Grazing Act Receipts: This revenue is paid to the State for total distribution based on the number of acres of Taylor Grazing Act land in each county in relation to the total number of acres of such land in the State. Although, state law (NDCC 15.1-27-24) requires the State Treasurer to distribute all of the revenue to the school districts within the county "on the basis of average daily membership of all students residing in the county" the funds are actually distributed to the counties and the counties then distribute all of the funds to the various school districts as required by law. Fourteen ND counties received revenue under this program in FFY16 for a statewide total of \$6,900. This section of law was moved (but unchanged) in the 2001 Session by HB1045.

Bankhead - Jones Receipts: This revenue is paid by the federal agency directly to the counties. Counties are required to use this revenue for schools and local roads – some counties dedicate the amount to local roads, others have a formula split with the schools. CY2016 receipts totaled \$22.2 million for the 9 ND counties involved, although only 4 counties received more than \$1 million. (This revenue is derived from 25% of the net revenue the federal agency receives from royalties and tenants on the land, after investments for conservation [dams, stock ponds, etc.])

PILT (Sec. 6902 "Entitlement Land") Payments: This revenue is paid by the federal agency directly to the counties. Counties are allowed to expend this revenue at their own discretion. Most place it in their general fund. The amount disbursed to each county is calculated two different ways, one of which is decreased by "prior year payments" from other public land revenues. (42 Counties received payments totaling \$1.5 million in CY2016)

Refuge Revenue Sharing Receipts: This revenue is paid by the federal agency directly to the counties. Counties however are required to further distribute <u>all</u> of the revenue to other political subdivisions. State Law (NDCC 11-27-09.1) requires that 25% of the revenue "*be apportioned among the townships*" and 75% "shall be apportioned among the school districts in which the land taken is located". As several of the counties receiving this revenue have no organized townships, they are allowed to retain the revenue to be used for road purposes within the unorganized townships containing the

federal land. (43 ND counties received \$470,000 of this revenue in FFY2016)

Mineral Royalty Payments: All of this revenue is paid directly to the State and deposited into the State General Fund. It was formerly governed by State Law (NDCC 15-40.1-13), which stated, "Such moneys must be deemed the first moneys withdrawn or expended from the general fund for state school aid purposes". This was amended by SB2202 in 1999 to gradually shift a portion of the funds to counties. 50% of the total revenue was distributed to counties in 2004 and that percentage has thereafter remained fixed. In CY2016, \$13.4 million was distributed to 16, primarily western, counties – although only 3 received in excess of \$1 million and about a third of the revenue accrued to McKenzie Co. A major rewrite of the education title of the century code moved the statute governing this distribution to NDCC 15.1-27-25. According to statutes, the "counties may use any money received under this section only for the planning, construction, and maintenance of public facilities and the provision of public services."

Federal Flood Control Payments: Flood control revenue is paid to the State for distribution to the counties in proportion to the area of land acquired by the United States under 33 USC 701(c)(3). This statute requires 75% of the revenue "on account of the leasing of lands acquired by the U.S. for flood control...shall be paid... to the State... to be expended as the state legislature may prescribe..."

This revenue is therefore largely distributed to counties that border the major Missouri River Reservoirs. These moneys are derived from income on federal land holdings in the county. State Law (NDCC 21-6-10) controls the further distribution of this revenue. It directs that 50% go to the school districts "*which have lost land subject to taxation*" because of federal acquisition. It further directs that 25% "must be paid to the county for road purposes to be expended as the county commissioners shall determine" and the "*final quarter must be allocated among the organized townships, if any, which have lost land subject to taxation*". (With the advent of Bakken Formation oil development, these payments increased and then decreased quite dramatically – State Treasurer's website contains county level details.) In CY2016 a total of \$1.4 million was distributed to 13 counties, although Mountrail County received almost a million of that.

As you are well aware, our continued concern at the national level is that federal payments are significantly less than the property tax that would otherwise be paid on this land, and this impacts counties, schools, townships, and the State as a whole.

I am Frank Tomac, rancher in Sioux County and President of the Cedar River Grazing Association, (CRGA).

The CRGA works in conjunction with the US Forest Service in managing the Cedar River National Grasslands. The Cedar River National Grasslands encompasses just over 6500 acres mostly in Sioux County with 480 acres in Grant County.

Part of the CRGA grazing fees goes towards Conservation Practices (CP's). We have such a small organization we cannot generate enough CP funds in one year to do any projects. With the help of the 2021 Legislature, we were able to initiate a lot of past due projects. However due to the speed of the Forest Service and the US Dept of Agriculture, we are unable to complete those projects and need an extension.

In addition, with more projects on the table, CRGA is asking for more money to impliment more projects for permit holders that missed out on the first moneys. These money's and projects are not wasted and benefit not only the permit holders, but also the wildlife and the public visitors for hunting and recreation.

I ask for a do-pass recommendation for SB 2290.

Testimony of Tom Bodine Deputy Agriculture Commissioner House Agriculture SB 2290 Room 327 C 03/09/2023

Chairman Thomas and members of the House Agriculture Committee, I am Tom Bodine Deputy Agriculture Commissioner, here on behalf of Agriculture Commissioner Doug Goehring. Thank you for the opportunity to appear before the committee. I am here today in support of Senate Bill 2290, which would provide funding for the Grassland Grazing Cost Share Program. The funding would be used for water development, fencing, conservation initiatives, compliance with federal permitting requirements, and projects that enhance wildlife habitat, increasing soil health, and enhancing the health grasslands.

The North Dakota Department of Agriculture is currently administering the cost share program for the 21-23 biennium and has identified that there still exists a significant need for additional funding. Due to the increase in costs, supply chain issues and a lag in the federal government's review process. The bill would also allow the Department to carry remaining funds in the current appropriation into the 23-25 biennium. I believe the cost share program has been very beneficial and has improved the overall functionality and the health of the grasslands. Again, thank you for letting me address the committee today. This program is important and valuable. I urge a do pass on SB 2290. I would be happy to answer any questions.

The Medora Grazing Association was started back in the thirties, there was not a lot of assistance at that time for the ranching community. You had to do with what you had to keep food on your table and feed your livestock.

We relied on mother nature to grow the grass, fill the water holes for our livestock.

Times have changed and there are programs/ funding for other industries for them to produce products for the state as well as the country. Ranching has been at the bottom of the pile.

With this Bill and funding in the last year has given some light, with shared funding, ranchers are able to improve their places, as well as the state and federal allotments for the cattle, to utilize areas of grass where there has been no water source, by spreading out the water cows and wildlife graze areas not used, which in turn rejuvenates grasses.

Areas that need new fencing to hold the cow on that grass, this in turn will give them a better quality of livestock to sell.

The ability to put in a pipeline and tanks, fences will help the future generations as they build up their operations and cow herds.

One other thing to think about is that these new water sources will also be utilized by bikers, trail riders and hikers, a water source out in the back county around Medora would certainly get utilized by wildlife as well tourist visiting the area. Hunters would also utilize these water sources. I have experienced many rescues on the Maada Hey trail over the years, many of these rescues were due to dehydration, with these water tanks available on public lands it will benefit these types of incidents from happening as often.

In the event of a grasslands fire, one of these 1200-gallon tanks would fill a slip-on truck two to four times, right there on site.

This water improvement project over the last year has provided a reliable water source to areas that desperately needed improvement. Getting this water to our grazing areas will improve the quality of livestock, the grasslands and help to improve the Forest Service's public lands for future generations. I have meet with several permittees and they feel this is a step forward improving their Ranches.

The Medora Grazing Association is in support of this bill-----to move forward
