

SUMMARY OF ELECTED OFFICIALS' SALARIES AMONG SELECTED STATES

This memorandum provides a summary of elected officials' salaries among the 10 states--Colorado, Iowa, Kansas, Minnesota, Missouri, Montana, Nebraska, Oklahoma, South Dakota, and Wyoming--included in the 10-state salary survey conducted by Human Resource Management Services. Information included in this memorandum was provided by representatives of the selected states, the states' websites, and the Council of State Governments' *Book of States*.
