The purpose of the proposed rule addition to 61-02-01-01 is to accommodate and facilitate pharmaceutical services in Long-term care facilities. The proposed rule 61-02-01-01 addition addresses the desire to incorporate automatic dispensing machine technology into nursing facilities.
