NOTICE OF INTENT TO AMEND ADMINISTRATIVE RULES

TAKE NOTICE that the North Dakota State Board of Psychologist Examiners will hold a public hearing to address proposed amendments to N.D. Admin. Code Title 66 on Tuesday, January 5th, 2016 at 2100 S. Columbia Road, Ste 202, Grand Forks, ND, from 9am until 11am or sooner if there is no public input on these rules. The purpose of the proposed amendments is to implement new and updated statutes. The proposed rulemaking implements bill number HB 1274, enacted by the legislature in the most recent session, concerning the practice of psychology and applied behavior analysis in North Dakota. The proposed amendments address updates and new statutes promulgated by HB 1274, clarify the language of the existing code, and improve readability. The proposed amendments are not expected to have an impact on the regulated community in excess of \$50,000.
