NOTICE OF INTENT TO REPEAL NORTH DAKOTA MEDIATION SERVICE ADMINISTRATIVE RULES TITLE 18.5 AND ADOPT ADMINISTRATIVE RULES TITLE 18.6

TAKE NOTICE that the Credit Review Board will hold a public hearing to address a proposal to repeal North Dakota Administrative Code, Title 18.5 and adopt North Dakota Administrative Code, Title 18.6 from 10:00 am to 12:00 pm on Wednesday, January 6, 2016, in the Missouri River Room, State Capitol Building, 600 East Boulevard Avenue, Bismarck, North Dakota.
