NOTICE OF INTENT TO AMEND
ADMINISTRATIVE RULES RELATING TO
N.D.A.C. CHAPTER 75-02-01.3
CHILD CARE ASSISTANCE

TAKE NOTICE that the North Dakota Department of Human Services will hold a public hearing to address proposed amendments to N.D. Admin. Code chapter 75-02-01.3 at 12:00 p.m. on Friday, June 10, 2022, in Bismarck, N.D. in Room 210, located on the second floor of the Judicial Wing of the State Capitol.

The proposed amendments to N.D. Admin. Code chapter 75-02-01.3, Child Care Assistance, are necessary to incorporate a streamlined payment process which includes issuing payments prospectively for Child Care Assistance Program (CCAP) payments.

The proposed changes are as follows:

Section 75-02-01.3-06 is amended to provide that all payments of child care assistance must be made to a provider.

The proposed amendments are not anticipated to have an impact on the regulated community in excess of \$50,000. No taking of real property is involved in this rulemaking action.

Copies of the proposed rules are available for review at human service zones and at human service centers. Copies of the proposed rules and the regulatory analysis relating to these rules, may be requested by telephoning (701) 328-2311.
