NOTICE OF INTENT TO AMEND ADMINISTRATIVE RULES RELATING TO N.D.A.C. CHAPTER 75-02-07.1 RATESETTING FOR BASIC CARE FACILITIES

TAKE NOTICE that the North Dakota Department of Human Services will hold a public hearing to address proposed amendments to N.D. Admin. Code chapter 75-02-07.1 at 1:30 p.m. on Tuesday, June 14, 2022, in Bismarck, N.D. in Room 210, located on the second floor of the Judicial Wing of the State Capitol.

The proposed amendments to N.D. Admin. Code chapter 75-02-07.1, Ratesetting for Basic Care Facilities, are necessary to standardize the cost reporting time period and simply the ratesetting process.

The proposed changes are as follows:

Section 75-02-07.1-01 is amended to revise the definition of "depreciation guidelines" to use a more current version of the American Hospital Association's depreciation guidelines. The section amends the definition of "report year" to reflect the change to a consistent reporting period for all providers, from July first through June thirtieth of the year immediately preceding the rate year.

Section 75-02-07.1-02 is amended to update the due date of the cost report and supporting documentation, which reflects the change to a uniform report year period. The option to elect a different report year was removed to reflect the change to a consistent report year for all providers.

Section 75-02-07.1-14 is amended to revise the top management compensation limit to use the previous year's top compensation increased by the consumer price index for all urban consumers.

The proposed amendments are not anticipated to have an impact on the regulated community in excess of \$50,000. No taking of real property is involved in this rulemaking action.
