<u>NOTICE OF INTENT TO AMEND</u> <u>ADMINISTRATIVE RULES RELATING TO</u> <u>N.D.A.C. CHAPTERS 75-03-38 AND 75-03-39,</u> <u>AUTISM SPECTRUM DISORDER VOUCHER PROGRAM AND AUTISM SERVICES</u> <u>WAIVER</u>

TAKE NOTICE that the North Dakota Department of Human Services will hold a public hearing to address proposed amendments to N.D. Admin. Code chapters 75-03-38 and 75-03-39 at 2:30 p.m. on Tuesday, September 7, 2021, in Bismarck, N.D. in Room 210, located on the second floor of the Judicial Wing of the State Capitol.

The proposed amendments to N.D. Admin. Code chapters 75-03-38 and 75-03-39, regarding the Autism Spectrum Disorder Voucher Program and Autism Services Waiver, are necessary to implement 2021 Senate Bills No. 2085 and 2089.

The proposed changes are as follows:

Section 75-03-38-01 is amended to provide a definition of "federal poverty level".

Section 75-03-38-02 is amended to provide that one of the conditions that must be met before a parent, custodian, or legal guardian may apply to participate in the voucher program is that the child's support need cannot be obtained through insurance or through other service systems, including educational and behavioral systems, and the federal Medicaid 1915(i) state plan amendment, to remove the six months residency requirement, and to update a citation.

Section 75-03-38-03 is amended to remove the requirement that an applicant for the autism spectrum voucher program must provide verification of North Dakota residency for at least six months, and also updates the requirement to provide signed releases of information only when necessary.

Section 75-03-38-04 is amended to provide for voucher support for a child with an autism spectrum diagnosis of up to \$7,500 per fiscal year in response to 2021 Senate Bill No. 2089. The section is also amended to update language and require the division to issue an autism voucher purchase form, instead of a voucher request form. The amended language also provides that for an item or service not included on the pre-approved list, a description of the item or service requested must be provided by a provider who is working with the eligible child and must state how the item

or service will compensate for a deficit created by an autism spectrum disorder. The section is also amended to provide that if a voucher is not used for thirty consecutive calendar days, the division shall inform the parent, custodian, or legal guardian that, if an additional thirty days pass without a voucher request or request for item or service, the voucher will be terminated in response to 2021 Senate Bill No. 2089. The section is also amended to provide that voucher funds may not be used for: housing or house maintenance; general entertainment, consumer electronics for every use, or recreation that benefits the entire family; household items; food; telephone or telecommunications; vehicles; clothing, personal goods, or personal treatments such as toiletries or cosmetics; and vacations.

Section 75-03-39-01 is amended to change the citations for General Authority and Law Implemented.

Section 75-03-39-02 is amended to extend eligibility for services under the Medicaid autism spectrum waiver through age fifteen, in response to 2021 Senate Bill No. 2085, and clarify that the child needs to meet the institutional level of care required by the centers for Medicare and Medicaid services.

The proposed amendments are not anticipated to have an impact on the regulated community in excess of \$50,000. No taking of real property is involved in this rulemaking action.
