NOTICE OF INTENT TO AMEND ADMINISTRATIVE RULES RELATING TO N.D.A.C. CHAPTERS 75-02-06 AND 75-02-07.1 RATESETTING FOR NURSING HOME CARE AND RATESETTING FOR BASIC CARE FACILITIES

TAKE NOTICE that the North Dakota Department of Human Services will hold a public hearing to address proposed amendments to N.D. Admin. Code chapters 75-02-06 and 75-02-07.1 at 1:30 p.m. on Thursday, December 10, 2015, in Bismarck, N.D. in Room 210, located on the second floor of the Judicial Wing of the State Capitol.

The proposed amendments to N.D. Admin. Code chapters 75-02-06 and 75-02-07.1, Ratesetting for Nursing Home Care and Ratesetting for Basic Care Facilities, are necessary to comply requirements found in 2015 House Bills No. 1234, 1277, 1353, and 1359.

The proposed changes are as follows:

Section 75-02-06-01 is being amended to remove basic care facilities from the definitions of "institutional leave day" and "therapeutic leave day" as used for nursing facility ratesetting.

Section 75-02-06-02.1 is being amended to correct an outdated reference and identify the ratesetting manual as a source of ratesetting procedures for nursing facilities.

Section 75-02-06-03 is being amended to update the nursing facility per bed cost limitation on single and double occupancy for the rate year beginning July 1, 2015, as required under 2015 House Bill No. 1234.

Section 75-02-06-10 is being amended to reflect language that is being added to section 75-02-07.1-31 requiring an allowable bad debt collection fee to be reasonable.

Section 75-02-06-12 is being amended to restructure subsections 1 and 2, to identify certain sales tax revenue as an offset to cost for nursing facilities as required by 2015 House Bill No. 1277, and to update language.

Section 75-02-06-12.1 is being amended to reflect the changes in section 75-02-06-12 dealing with certain sales tax revenue of a nursing facility as required by 2015 House Bill No. 1277, and to address the changes made to allowable educational costs set forth in 2015 House Bill No. 1353.

Section 75-02-06-16 is being amended to restructure subdivision a or subsection 7 addressing rates for a nursing facility changing ownership.

Section 75-02-06-26 is being amended to remove language that is duplicative of language that exists in the North Dakota Century Code.

Section 75-02-07.1-01 is being amended to include bad debt in the "food and plant costs" definition for a basic care facility.

Section 75-02-07.1-05 is being amended to allow up to thirty, instead of fifteen, days of payment of room and board for medical care leave for a basic care facility, as required by 2015 House Bill No. 1359.

Section 75-02-07.1-08.1 is being amended to address bad debt and bad debt collection fees as food and plant costs.

Section 75-02-07.1-10 is being amended to identify when bad debt expenses are not nonallowable costs for a basic care facility.

Section 75-02-07.1-11 is being amended to is being amended to restructure subsections 1 and 2, to identify certain patronage dividends credited to a basic care facility as an offset to costs, and to update language.

Section 75-02-07.1-22 is being amended to update the direct care and indirect care limit rates for rate years beginning July 1, 2016, and to address calculation of current year limits for basic care facilities as required by 2015 House Bill No. 1359.

Section 75-02-07.1-31 is being created to accommodate bad debts and fees paid for the collection of those bad debts as allowable costs for basic care facilities.

The proposed amendments are anticipated to have an impact on the regulated community in excess of \$50,000. No taking of real property is involved in this rulemaking action.
