**FULL NOTICE OF INTENT TO AMEND
AND CREATE NEW ADMINISTRATIVE RULES REALTING TO PROPOSED
CHANGES TO THE REQUIREMENTS TO OBTAIN AND RENEW SCHOOL
PRINCIPAL CREDENTIALS**

TAKE NOTICE that the North Dakota Department of Public Instruction (NDDPI) will hold a public hearing to address proposed changes to N.D. Admin. Code 67-11, Educator Credentials, at 1:30 PM on Monday, March 11, 2019, in Meeting Room E, located at the Quality Inn, 1030 E. Interstate Ave., Bismarck, ND 58503. The purpose of the proposed changes is to repeal 67-11-01, Elementary Principal's Credential; to repeal 67-11-06, Secondary Principal's Credential; to create 67-11-21, Principal Credentials. These changes are being proposed to realign grade levels defined in the requirements for the principal credential to the grade levels required by the Education Standards and Practices Board, redefine the requirements for the provisional principal credential, redefine standards for the principal credential, allow an option for a grades K-12 principal credential, update requirements to renew the principal credential, and begin to phase out the existing level II principal credential. The proposed rule is expected to have an impact on the regulated community in excess of \$50,000.

The proposed rules may be reviewed at the NDDPI Office of School Approval and Opportunity, ND State Capitol, 600 E. Boulevard Avenue, Bismarck, ND 58505-0440. Written and oral comments on the proposed rules sent to the above address or telephone number and received by 4:00 p.m. on Friday, March 22, 2019, will be fully considered.
