FULL NOTICE OF INTENT TO AMEND ADMINISTRATIVE RULES RELATING TO DEPARTMENT OF WATER RESOURCES OPERATIONS

TAKE NOTICE that the Department of Water Resources will hold a public hearing to address proposed amendments to the following N.D. Admin. Code articles:

89-01 (General Administration)

89-02 (Drainage of Water)

89-03 (Water Appropriations)

89-05 (Construction of Dikes)

89-06 (Funding from the Resources Trust Fund)

89-08 (Dams, Dikes, and Other Devices)

89-10 (Sovereign Lands)

89-11 (Drought Disaster Livestock Water Assistance Program)

89-12 (Municipal, Rural, and Industrial Water Supply Program)

89-14 (Public Highway Stream Crossings).

Most of the proposed changes are to update language to reflect the new structure of the department, with the director as the agency head rather than the state engineer, as enacted during the 2021 legislative session through House Bill 1353. In addition, proposed changes in N.D.A.C. Ch. 89-08-01 reflect changes to the definitions used for dam hazard classification.
