



NOTICE OF INTENT TO
ADOPT, AMEND, OR REPEAL ADMINISTRATIVE RULES

TAKE NOTICE that the Education Standards and Practices Board will hold a public hearing to address proposed new, amendments to, or repeal of N.D. Admin. Code 67.1 at 1:30 p.m. on January 24, 2014 at the Education Standards and Practices Board, 2718 Gateway Avenue, Suite 303, Bismarck, ND. The purpose of the proposed rules and amendments is to implement statutes. The proposed rules and amendments addresses late fees, policy, and language changes in educator licensure. The proposed rulemaking implements bill number 1296, enacted during the most recent legislative session, concerning other state educator licenses. The proposed rules and amendments is not expected to have an impact on the regulated community in excess of \$50,000.
