## **NOTICE OF INTENT TO**

### **AMEND ADMINISTRATIVE RULES RELATING TO**

#### **NDCC 43-62 MEDICAL IMAGING AND RADIATION THERAPY**

TAKE NOTICE that the North Dakota Medical Imaging and Radiation Therapy Board will hold a public hearing to address amendments to N.D. Administrative Code Title 114. The hearing will be held:

**December 17, 2019 at 10:00 am – 11:00 am in the Fort Union Room**  
**at the North Dakota State Capitol**  
**South entrance, 600 East Boulevard Avenue, Bismarck, ND.**

The proposed amendments are North Dakota Administrative Code Title 114, North Dakota Medical Imaging and Radiation Therapy Board and include the following:

- Article 114-01-01 General Administration
- Article 114-02-03 Licensure by Endorsement
- Article 114-02-05 Recognized Certification of Organizations and Credentials
- Article 114-03-01 Disciplinary Process

The purpose of the proposed amendment is compliance with SB 2306, enacted during the most recent legislative session, concerning licensure of military spouses. The proposed amendment is not expected to have an impact on the regulated community in excess of \$50,000. No taking of real property is involved in this rulemaking amendment.
