NOTICE OF INTENT TO [ADOPT, AMEND OR REPEAL]
ADMINISTRATIVE RULES

TAKE NOTICE that the North Dakota State Electrical Board will hold a public hearing to address proposed new rules and amendments to N.D. Admin. Code Article 24-02 at 1:15 p.m. on November 14, 2013, at the Red River Room, State Capitol, Bismarck, North Dakota. The purpose of the proposed new rules and amendments is to adopt the NFPA 70 2014 edition National Electrical Code and NFPA 101 2012 edition Life Safety Code. The proposed new rules and amendments address:

- Entire 24-02: Adopts the NFPA 70 2014 edition National Electrical Code and NFPA 101 2012 edition Life Safety Code.
- 24-01-01-01(5): Eliminates the NDSEB District Map, which will be available on an updated basis at www.ndseb.com.
- 24-02-01-02(1)(b)(1): Corrects a typographical error from the 2011 code and replaces “wiring” with “repairing.”
- 24-02-01-02(1)(d): Clarifies NDSEB procedures for submitting an Application for Electrician’s License.
- 24-02-01-03(6): Adds “or metal cable (MC) rated for the environment” in order to be uniform with national electrical codes.
- 24-02-01-03(6) - Last Paragraph: Redefines language to coordinate to the codes and standards of the state building code concerning metal raceways and fire barriers.
- 24-02-01-07(6): Revises language concerning 15 and 20 amp 125 volt receptacles to be current on national electrical codes.
- 24-02-01-09(1): Added exception to rule in relation to NEC 240.24(A).
- 24-02-01-12: Added “or listed devices,” to include two-part modular homes.
- 24-02-01-19: Renumbers paragraphs.
- 24-02-01-19(2)/24-02-01-19(5): Increases requirement where the cost of the repair work or additional installation exceeds \$300.00 to \$750.00.
- 24-02-01-19(2)(a)(c)(d): Redefines language to conform to paper and electronic wiring certificates.
- 24-02-01-19(2) - Last Paragraph: Increases job cost to \$20,000 for wiring certificates to be submitted within one year.

- 24-02-01-19(4): Eliminates this section as it is redundant in 24-02-01-19(2)(a).
- 24-02-01-19(14): Clarifies procedures for property owners doing their own electrical work.

The proposed new rules and amendments are not expected to have an impact on the regulated community in excess of \$50,000.00.
