FULL NOTICE OF INTENT TO ADOPT AND AMEND ADMINISTRATIVE RULES

TAKE NOTICE that the State Gaming Commission will hold a public hearing to address proposed amendments to N.D. Admin. Code article 99-01.3 at 10:00 a.m. on Wednesday, April 27, 2022, in the Brynhild Haugland Room, State Capitol, 600 E. Boulevard Ave., Bismarck, N.D. The purpose of the proposed amendments is to address industry issues, modify the conduct of games, improve accountability, clarify the rules, and implement law changes. The proposed amendments address organization licenses and permits, general rules, accounting rules, bingo, electronic quick shot bingo, raffles, pull tabs and similar games, sports pools, twenty-one, poker, calcuttas, paddlewheels, pull tab, electronic pull tab and prize board dispensing devices, eligible uses, and distributors and manufacturers of gaming equipment.

The proposed amendment is not expected to have an impact on the regulated community in excess of \$50,000.

The proposed rulemaking implements legislation enacted in the 2021 legislative session and 2021 special session: House Bill 1162 relating to permitting licensed organizations to sell raffle tickets online and accept electronic payments for raffle ticket purchases; House Bill 1212 relating to the creation of a charitable gaming fund and gaming tax; House Bill 1263 relating to eligible uses for charitable gaming net proceeds; House Bill 1509 relating to charitable gaming tax; Senate Bill 2251 relating to the use of net proceeds for a political purpose; Senate Bill 2283 relating to the duties of the Attorney General.
