NOTICE OF INTENT TO AMEND ADMINISTRATIVE RULES RELATING TO N.D.A.C. CHAPTER 75-02-01.2 TEMPORARY ASSISTANCE FOR NEEDY FAMILIES PROGRAM

TAKE NOTICE that the North Dakota Department of Human Services will hold a public hearing to address proposed amendments to N.D. Admin. Code Chapter 75-02-01.2, at 3:30 p.m. on Monday, September 22, 2008, in Bismarck, N.D. in the Pioneer Room – Room G-15, located on the ground floor of the Judicial Wing of the State Capitol.

The proposed amendments to N.D. Admin. Code Chapter 75-02-01.2, Temporary Assistance for Needy Families Program, are to clarify and revise the rules in accordance with federal and state standards and laws, and to comply with Senate Bill No. 2186 of the Sixtieth Legislative Assembly, relating to establishment of a transitional assistance program. The proposed amendment may have an impact on the regulated community in excess of \$50,000.

Section 75-02-01.2-02.1, Diversion assistance is amended to clarify the eligibility and benefits of the diversion assistance program. (Included the requirement to participate in Pathways to Work and the consequences for not following through with the referral to Pathways to Work. Add language to clarify the four month limitation and use of supportive services based on TANF rules.)

Section 75-02-01.2-02.2, Kinship care assistance is amended to add language to include the executive director of the department or the division of juvenile services as custodian of a child for the child to be eligible for kinship care assistance.

Section 75-02-01.2-02.3, Transition assistance is created to establish eligibility requirements for transition assistance pursuant to 2007 Senate Bill No. 2186.

Section 75-02-01.2-12, Determining claims of good cause is amended to reflect more than one contractor for the JOBS program.

Section 75-02-01.2-35.1, Time limit on certain benefits – Exceptions is amended to change "filing unit" to "temporary assistance for needy families household" and to remove the subsection which allowed the state a lifetime limit for caretakers with a disqualification.

Subdivision a of subsection 2 of section 75-02-01.2-51(2)(a) is amended to clarify the standard employment expense allowance for any child who is a full-time elementary or high-school student.

Section 75-02-01.2-52, Voluntary quit or refusal of employment is amended to clarify the entity that must approve good cause for a voluntary quit of employment and to reflect more than one contractor for the JOBS program.

Section 75-02-01.2-60, Computing payment if stepparent or alien parent income is deemed is amended to allow the department to provide the marriage incentive to more TANF individuals.

Section 75-02-01.2-73, Health tracks is amended to remove the penalty for not following through with a Health Track screening.

Section 75-02-01.2-80, Good cause determination is amended to reflect more than one contractor for the JOBS program, to change the requirement from ten days to two days for the employment contractor to send notification of a good cause meeting to a TANF client who is not complying with program requirements, and to change the requirement to meet with the employment contractor from seven days to five days to present good cause for not meeting requirements.

Section 75-02-01.2-82, Job opportunities and basic skills program – **Definitions** is amended to add definitions for "eligible individual" and "work-eligible individual".

Section 75-02-01.2-83, Job opportunities and basic skills program – Basic requirement is repealed.

Section 75-02-01.2-84, Job opportunities and basic skills program – Satisfactory participation is amended to reflect changes in the Definitions section.

Section 75-02-01.2-86, Job opportunities and basic skills program – Tribal native employment works program is amended to reflect changes in the Definitions section.

Section 75-02-01.2-87, Job opportunities and basic skills program – Exemptions from participation is amended to add an exemption policy for a parent providing care for a disabled family member living in the home.

Section 75-02-01.2-89, Job opportunities and basic skills program – Orientation, assessment, and employability planning is repealed.

Section 75-02-01.2-90, Job opportunities and basic skills program – Supportive services and transitional supportive services is amended to reflect more than one contractor for the JOBS program and to clarify approval to move for greater employment opportunities.

Section 75-02-01.2-91, Job opportunities and basic skills program – Educational activities related to secondary education, basic and remedial education, or education in English proficiency is repealed.

Section 75-02-01.2-92, Job opportunities and basic skills program – Job skills training directly related to employment is repealed.

Section 75-02-01.2-93, Job opportunities and basic skills program – Unsubsidized employment is repealed.

Section 75-02-01.2-94, Job opportunities and basic skills program – Job search and job readiness is repealed.

Section 75-02-01.2-95, Job opportunities and basic skills program – Job development and job placement activities is repealed.

Section 75-02-01.2-96, Job opportunities and basic skills program – Vocational education is repealed.

Section 75-02-01.2-97, Job opportunities and basic skills program – Provision of child care services to another participant engaged in a community service program is repealed.

Section 75-02-01.2-98, Job opportunities and basic skills program – Work experience and community service program is repealed.

Section 75-02-01.2-100, Job opportunities and basic skills program – On-the-job training is repealed.

Section 75-02-01.2-101, Job opportunities and basic skills program – Subsidized public and private sector employment is repealed.

Section 75-02-01.2-102, Job opportunity and basic skills program – Failure or refusal to participate is amended to reflect more than one contractor for the JOBS program.

Section 75-02-01.2-103, Job opportunities and basic skills program – Good cause for failure or refusal to comply with a referral to, or participate in, the job opportunities and basic skills program is amended to reflect changes in the Definitions section and to remove the provision that allows the department to limit the number of individuals referred to the job opportunities and basic skills program.
