## NOTICE OF INTENT TO AMEND ADMINISTRATIVE RULES RELATING TO N.D.A.C. SECTION 75-02-09.4 LIMITATIONS ON PAYMENT FOR EYE SERVICES

TAKE NOTICE that the North Dakota Department of Human Services will hold a public hearing to address proposed amendments to N.D. Admin. Code Chapter 75-02-02-09.4 at 3:30 p.m. on Tuesday, August 11, 2009, in Bismarck, N.D. in the AV Room – Room 210, located on the second floor of the Judicial Wing of the State Capitol.

The proposed amendments to N.D. Admin. Code Section 75-02-02-09.4, Limitations on Payment for Eye Services, are necessary to comply with an appropriations measure passed during the 2009 legislative session, as directed by House Bill No. 1012. The proposed amendment will have an impact on the regulated community in excess of \$50,000.

**Chapter 75-02-02-09.4,** is amended to change the limits on eye services for adults eligible for the North Dakota Medicaid program. The current limit is one pair of eyeglasses every three years and one refractive eye exam every three years. The new limit would be once every two years for both the exam and the eye glasses.

Copies of the proposed rules are available for review at county social services offices and at human service centers. Copies of the proposed rules and the regulatory analysis relating to these rules may be requested by telephoning (701) 328-2311. Written or oral data, views, or arguments may be entered at the hearing or sent to: Rules Administrator, North Dakota Department of Human Services, State Capitol - Judicial Wing, 600 E. Boulevard Ave., Dept. 325, Bismarck, ND 58505-0250. Written data, views, or arguments on the proposed rules must be received no later than 5:00 p.m. on Monday, August 24, 2009.
