TAKE NOTICE that the North Dakota Board of Nursing will hold a public hearing to address proposed new, amendments or repeal of North Dakota Administrative Code title 54. The hearing will be:

Specialty Practice Registered Nurse; Chapter 54-03.2-03. Nurse Administrator; Chapter 54-03.2-04. Faculty; Chapter 54-03.2-06 Curriculum; Chapter 54-03.2-07. The purpose of the proposed new and amendments is to update, utilize the uniform licensure requirements related to the nurse licensure compact for licensure and registration and provide clarification to previous rules.
