On December 24, 2009, the North Dakota Department of Health filed the attached Notice of Intent to Adopt Administrative Rules with the Legislative Council. These rules have since been adopted, with slight modification, as final rules by the Health Council, but are awaiting approval by the Administrative Rules Committee and the United States Environmental Protection Agency. The Department has found that emergency rulemaking is necessary for the proposed N.D. Admin. Code § N.D.C.C. § 33-16-02.1-09(3)(b) and is declaring it to be an interim final rule effective as of the date that this letter and the Department's Finding and Statement of Reason are filed with the Legislative Council.



Dear Governor Hoeven:

The North Dakota Department of Health recently received letters from the North Dakota State Water Commission and the city of Devils Lake describing widespread flood impacts affecting the environment, economic stability and public health in the Devils Lake region (see enclosed). The letters describe the need for an emergency response to flood conditions and request the department to initiate immediate action.

The following issues are of concern:

- 1) Devils Lake is now at 1451.7 ft-msl. This is 1.0 feet higher than the historical record set on June 27, 2009. USGS studies have indicated that the Devils Lake basin is in a wet cycle at this time. They also indicated that if Devils Lake reaches 1452.0 by the end of June, it has a 10-percent chance of overflowing into the Sheyenne River in the next 10 years, assuming no discharge from the State outlet. This would have major, adverse downstream consequences.
- 2) From May 15, 2009 to May 15, 2010, Devils Lake has increased 1.6 feet in depth with the total volume increase for Devils Lake and Stump Lake of 277,000 acrefeet. To reach 1458.0 feet in both lakes would require a storage increase of 1,372,000 acre-feet. This could occur in five years with precipitation similar to 2010, and three years with 2009 precipitation. Although the probability of having three consecutive years of precipitation similar to 2009's may be low, it is apparent that in a wet cycle, increasing lake levels can be expected to occur.
- 3) Rising lake levels inundate private property and productive farmland and stress the capacity of existing dike systems, roads acting as dikes, and other structures not designed to retain water. Their failure would result in additional flooding of cities and rural areas, impacting land productivity as well as municipal and rural infrastructure.

In an effort to address the widespread flood impacts in the Devils Lake region, the department finds that emergency rulemaking is necessary and is requesting the

authority to implement an interim emergency rule to reclassify stream water quality standards for a portion of the Sheyenne River. This action would allow an immediate increase of discharge from the west end of Devils Lake in an effort to stabilize or decrease lake levels, thus reducing the impact of flooding.

Under N.D.C.C. § 28-32-03, emergency rules are appropriate if "[i]mminent peril threatens public health, safety or welfare, which would be abated by emergency effectiveness." With your approval, the Department of Health has the authority to determine that emergency rulemaking is necessary and declare the rule to be an interim final rule. An emergency rule becomes effective "no earlier than the date of filing with the legislative council of the notice required by section 28-32-10." Notice for this rule has already been filed with the Legislative Council, as the rule has already been subject to the public participation process and been adopted by the Health Council. The rule will become permanently effective once it is approved by the Administrative Rules Committee, published in the North Dakota Administrative Code, and approved by the United States Environmental Protection Agency. Due to the emergency conditions in Devils Lake, the Department would like to use emergency rulemaking so that the rule may be effective while the rule is going through the final stages of the formal rulemaking process. With your approval, the Department will declare the rule to be effective upon the filing of its Finding and Statement of Reasons with the Legislative Council. As with all rules, the emergency rule will expire after 180 days, unless adopted as a final rule.

We request your approval of the attached emergency rule.

NOTICE OF EMERGENCY EFFECTIVENESS OF PROPOSED AMENDMENT TO N.D. ADMIN. CODE § 33-16-02.1-09(3)(b)

TAKE NOTICE that the North Dakota Department of Health has, with the approval of the governor, found that emergency rulemaking is necessary and is declaring the proposed amendment to N.D. Admin. Code § 33-16-02.1-09(3)(b) effective as of May 26, 2010. This proposed amendment has been adopted by the North Dakota Department of Health but is awaiting review by the Administrative Rules Committee, publication in the North Dakota Administrative Code, and approval by the United States Environmental Protection Agency.

The proposed amendment to N.D. Admin. Code § 33-16-02.1-09(3)(b) adds a site-specific sulfate standard of 750 mg/L for the Sheyenne River from its headwaters to 0.1 mile downstream from Baldhill Dam.

NOTICE OF INTENT TO AMEND ADMINISTRATIVE RULES RELATING TO STANDARDS OF WATER QUALITY

TAKE NOTICE that the North Dakota Department of Health will hold a public hearing to address proposed amendments to the Standards of Quality for Waters of the State, N.D. Admin. Code Chapter 33-16-02.1, at the Environmental Training Center, 2639 East Main Ave., Bismarck, N.D. on Wednesday, February 17, 2010, at 1:00 p.m.

The purpose of the proposed amendments is to complete the Department's triennial review of the Standards of Quality for Waters of the State, as required by 33 U.S.C. § 1313(c). The Department is proposing amendments to N.D.C.C. § 33-16-02.1-09, Table 1, Table 2, and Appendix II, as part of this triennial review. The proposed amendments are as follows:

- 1. Revise N.D.C.C. § 33-16-02.1-09(1)(b) classification of Class IA streams to clarify that softening or other treatments may be considered in determining whether the ambient water quality meets the Department's requirements and to remove the municipal and domestic use designation for the segment of the Sheyenne River from its headwaters to 0.1 mile downstream from Baldhill Dam. Revisions to Appendix I, Stream Classifications, were also made to reflect this change in the Sheyenne River's designated use.
- 2. Revise N.D.C.C. § 33-16-02.1-09(3)(b) numeric standards for Class IA streams to add a site-specific sulfate standard for the Sheyenne River from its headwaters to 0.1 mile downstream from Baldhill Dam.
- 3. Revise N.D.C.C. § 33-16-02.1-09(3)(e) numeric standards for lakes and reservoirs to clarify that reservoirs located on Class 1A, Class II, or Class III streams have the parameter limitations for that class stream.
- 4. Revise Table 1, Maximum Limits for Substances in or Characteristics of Class I Streams, to remove the fecal coliform maximum limit and make editorial changes to the nitrates maximum limit.
- 5. Revise Table 2, Water Quality Criteria, to update numeric criteria based on toxicological information from the U.S. Environmental Protection Agency.
- 6. Revise Appendix II, Lake Classification, to clarify that it applies to reservoirs and to clarify that a default classification of Class 4 applies to lakes not specifically listed in Appendix II. Editorial corrections were also made to certain lakes or reservoirs.

The proposed amendments are not expected to have an impact on the regulated community in excess of \$50,000, so a regulatory analysis was not required.
