NOTICE OF INTENT TO AMEND ADMINISTRATIVE RULES RELATING TO N.D.A.C. SECTION 75-02-07.1-14 RATESETTING FOR BASIC CARE

TAKE NOTICE that the North Dakota Department of Human Services will hold a public hearing to address proposed amendments to N.D. Admin. Code section 75-02-07.1-14 at 2:30 p.m. on Thursday, August 4, 2011, in Bismarck, N.D. in the AV Room – Room 212, located on the second floor of the Judicial Wing of the State Capitol.

The proposed amendments to N.D. Admin. Code section 75-02-07.1-14, Ratesetting for Basic Care, are necessary to avoid a delay in implementing HB 1423 which was passed by the 2011 Legislative Assembly.

The proposed changes are as follows:

Section 75-02-07.1-14 is amended to allow a basic care facility that is combined with a hospital to use the management compensation allocation method set out in N.D.A.C. chapter 75-02-06. This would allow a basic care facility that is combined with a hospital to use the same allocation method as a nursing facility that is combined with a hospital or basic care facility.

The proposed amendments are not anticipated to have an impact on the regulated community in excess of \$50,000. No taking of real property is involved in this rulemaking action.
