
NOTICE OF INTENT TO  
REPEAL AND AMEND ADMINISTRATIVE RULES

TAKE NOTICE the North Dakota Department of Agriculture (NDDA) will hold a public hearing to repeal N.D. Administrative Code (NDAC) Article 7-12-02 (Anhydrous Ammonia Nurse Tank and Storage Container Lock Pilot Program), add new section Article 7-12-03 (Risk Management Program for Agricultural Anhydrous Ammonia Facilities), address proposed amendments to Article 7-12-01 (Anhydrous Ammonia Standard), address proposed amendments to Article 7-03.2 (Dairy Division), and address proposed amendments to Article 7-13 (Meat Inspection) of the NDAC. The hearing will be held at the NDDA Conference room at the capitol, Bismarck, ND on December 4, 2012 at 1:00pm. The proposed amendments are to update dairy regulations, meat inspection regulations and anhydrous regulations to meet federal and state laws and regulations. The proposed amendments are not expected to have an impact on the regulative community in excess of \$50,000.
