## DAKOTA'S LEGISLATURE.

## A Complete Report of the Proceedings of the Council and the House.

Fifteenth Session-Tenth Day. Council. THURSDAY, JAN. 18, Called to order at ten a. m., by President Scobey.

Prayer by the chaplain. Roll call. All present. PETITIONS.

Mr. Nickeus presented the petition of Elias McCauley, of Spink, claiming that he is entitled to the seat in the council now held by W. H. Donaldson. claims his election by 148 majority. Mr. Nickeus moved that petition, together with all testimony, be referred to the committee on elections, and that they be instructed to investigate the case. Mr. Donaldson seconded the motion. Car-

REPORT OF COMMITTEES,

Session Notes.

A petition from Brookings county asks for legislation to secure the prompt destruction of glandered horses. A bill has been prepared and will undoubtedly pass to reach the end desired.

Councilman Jerauld is asked to present a bill to prohibit the importation of Texas and Cherokee cattle into Dako-ta. It is claimed that in Lincoln county their introduction has resulted in the death of a great many native cattle. It is claimed that, while disease is not communicated by occasional mixing of the herds in yards, that the native co sure to suffer by grazing on the same grounds, Mr. Jersuld, in conversation, gave an instance as coming under his own observation where a valuable herd had been severely attacked and decimated through feeding on a tract from which the Texans and Cherokees had been late-ly removed. It is thought that large districts in the territory may be opposed to the legislation asked and it is not the purpose to push the matter without due consideration of all interests. One of the crowning glories of Dakota is her healthfulness for man and beast. It would seem true statesmanship to take time by the forlock a little in guarding

time by the tortock a little in guarting against imported diseases.

Mr. Rinehart's house bill for the relief of sufficers from hall storms in the Black Hills counties, provides that the taxes of such sufficers for 1828 be remistaxes of such sufferers for 1882 be remitted, upon the presentation of the proper affidavits. There are probably about fifty persons who will take advantage the act if it becomes a law and they are needy and deserving. During July and August of last year portions of the hills were visited by destructive storms, which completely wiped out the growing crops. This deprived many persons of the results of the year's labor and left them in close circumstances.

Mr. Inman's house bill for the organization and government of the university of Dakots provides for the creation of a board of university regents, consisting of seven persons, the governor of the territory to be president and the president of university to be a member. The other five members to be appointed by the governor and confirmed by the council. These regents are to control the affairs of the university.

Two bills were introduced in the house to-day for the creation of new counties. One was presented by Mr. Benson, by request, to create Becker county from portions of Dickey, Brown and Ransom and another by Mr. Allred to create the county of Raymond from the western tier of towns in Cass county and the two castern tiers of some in Sarnes county.
