Section 44-08-04.3 of the North Dakota 8 9 Century Code is hereby created and enacted to read as follows: 10 44-08-04.3. MOVING EXPENSE - ALLOWANCES - VERIFICATION.) The head of any department, institution, or agency may 11 authorize the payment of moving expenses incurred by an 12 employee when that employee is transferred from one duty . 13 14 station to another duty station for the purpose of assuming a 15 new duty assignment and fulfilling a need of that department, 16 institution, or agency. Relocation costs payable will be as 17 follows: 18 1. All actual costs of moving personal household goods 19 and furnishings, not to exceed six thousand pounds. 20 2. Mileage at the current rate for one personal vehicle 21 to a new duty station. 3. Actual meals and lodging costs for employee and

immediate family, not to exceed three days.

1	4. In-state travel expenses for the employee at the new
2	duty station for actual time needed to accomplish the
3	relocation, not to exceed thirty days.
4	Provided, however, that payment of the expenses itemized in
5	subsections 1 through 4 shall not exceed one thousand dollars.
6	Verification for expenses under subsection 1 shall be a paid
7	receipt from a licensed moving agency, licensed trailer
8	transportation company, trailer rental agent, or other licensed
9	moving company; verification for expenses under subsection 2
10	shall be highway mileage between the location sites;
11	verification for expenses under subsection 3 shall be receipts
12	for meals and lodging; and verification for expenses under
13	subsection 4 shall be according to section 44-08-04. An
14	employee, for the purpose of this section, shall be one who has
15	served at least one year, including a probationary period, and
16	whose retention is approved after such probationary period.
