This note shows the impact of combining the State Board of Higher Education and the Board of Vocational Education Board Budgets.							
Present budgets provide for 7 regular members and one student member of the Board of Higher Education in the Higher Education budget. The Vocational Education budget provides for three members of the Vocational Board. Three more are provided in the Superintendent of Public Instruction budget.							
This note shows the effect of reducing the number of Board members from 11 in the two budgets to 10 in the combined budget. (9 voting members and 1 student non voting.)							
The Superintendent of Public Instruction budget will have a cost addition to assume the 3 members of the former Vocational Education Board for they will continue to have a seat on the Board for Public School Education. The cost added for the 3 will be \$27,500 on a current basis.							
Overall then the net effect of the Boards merging is a saving of \$9,841 and a possible addition of \$27,500 for a net cost addition of \$17,659. State Fiscal Effect: (continued)
