HB 1544: A BILL for an Act to create and enact a new section to chapter 23-10 of the North Dakota Century Code, relating to mobile home owners leasing their homes in mobile home parks.

HCR 3014: A concurrent resolution urging the United States Congress to investigate the extent and value of railroad land grant assets, and the utilization of income therefrom; and urging Congress to establish policies with respect to use of land grant assets and the income therefrom.

Was read the first time and referred to the Committee on Transportation.

Reps. Brokaw, Shockman, W. Williams and Sens. Barth, Kusler, Wogslund introduced:

HCR 3015: A concurrent resolution urging Congress to direct the United States Attorney General to bring legal action against the Burlington Northern Railroad in order to prohibit that railroad from separating land grant assets from the remainder of the railroad's capital.

Was read the first time and referred to the Committee on Transportation.

Reps. Brokaw, Shockman, W. Williams and Sens. Barth, Kusler, Wogslund introduced:

HCR 3016: A concurrent resolution urging Congress to require any railroad abandoning a portion of its line and ceasing service along that portion to forfeit all or a portion of the land and minerals granted to the railroad.

SB 2201: A BILL for an Act to create and enact a new section to chapter 15-40 of the North Dakota Century Code, relating to school aid appropriation for alternative programs for dropout students age sixteen through eighteen.

SB 2202: A BILL for an Act to amend and reenact section 15-45-02 of the North Dakota Century Code, relating to kindergarten curriculum, rules, and length of kindergarten term. Was read the first time and referred to the **Committee on Education**.
