# POINT OF PERSONAL PRIVILEGE

REP. O. HANSON: Madam Speaker: I rise to a point of personal privilege and request that my remarks be printed in the Journal.

Madam Speaker, and members of the Assembly and especially our Speaker Tish Kelly, Majority Leader Dick Backes, and Minority Leader Earl Strinden: This morning I want to ask a very pointed question of you three. I would have liked to put the same question to the Senate leaders, but they are not here.

Just when is this Legislative Assembly going to come to a close? When the agreement was reached last Saturday on wages for state employees, we all thought the end was in sight, but here is another Saturday coming and it appears we are no closer to finishing than we were then. We have become the laughing stock back home. People are calling and wondering when are we going to shut down this silly circus and they are serious.

It's become a costly affair for me. I'd arranged my calving season for two weeks later this season because of the session, but because of the dillydallying around here, I'm losing calves back home since I'm not there to run the night shift. My wife is losing patience with me and I sit down here twiddling my thumbs. Very frustrating!

Representative Backes, I know it takes two to tangle and it's not all your fault. Still, I remember the campaign last fall. You said many times you were going to be Majority Leader and then things would be different. I know, because you and I were opponents and shared the same platforms. I don't think this is what you meant when you said that.

Back home on the ranch when it's a busy season, calving, spring's work, harvesting, etc., we work long hours, sunup to sundown and longer. It's the only way to get work done. Here we are working practically banker's hours and some not working at all during the week, yet I hear rumors that we will be working the same schedule tomorrow, which is Saturday. I'm scheduled to take part in a roast of our good friend, Eric Berntson, Deputy Premier of Saskatchewan, a long way north of here, tomorrow afternoon, and yet we are doing nothing.

Politics is the art of compromise and I know you've said you've come as far as you intend to. We have bills still in committee, let alone conference committees, let's get them out, bring them to the floor, and see what will fly. You leaders should be meeting more than for a half-hour a day. Somehow, somewhere, this charade must end. As a parting thought, I've run out of shirts and shorts! Good luck!

## POINT OF PERSONAL PRIVILEGE

REP. STRINDEN: Madam Speaker: I rise to a point of personal privilege and request that my remarks be printed in the Journal.

Madam Speaker: A colleague and friend has been somewhat maligned recently with regard to the weather modification program. I am going to say some things that I don't think Senator Streibel would say, but most certainly should be said.

Back some years ago during the Carter administration, Senator Streibel was appointed by President Carter to the National Weather Modification Board. This is a nonsalaried board. He served for a number of years, traveling extensively, spending a good deal of his own money and time, studying and reviewing the weather modification programs not only nationally, but having access to information of what is happening in other countries. In his capacity as a member of this board, he met some of the finest minds in the nation with regard to this aspect of research.

Through his efforts, million of dollars of research moneys have come to the state of North Dakota. There is a potential, I do believe, for North Dakota to become the leading research center on weather modification, not only in the nation, but in the world.

I really believe that Senator Streibel would have felt strongly about weather modification regardless of any involvement by a member of his family. I truly believe that to be incidental. Most recently there was a correction in the Grand Forks Herald. Among other things it said "Streibel's son, Kent Streibel, is assistant flight instructor in the UND Aviation Department. He does not work for the weather modification program."

There are those who feel strongly both ways about weather modification, but we should clearly and completely understand the involvement this individual has had, and what his motives really are, not to have those motives or that involvement misunderstood or misrepresented.

# POINT OF PERSONAL PRIVILEGE

REP. S. F. HOFFNER: Madam Speaker: I rise to a point of personal privilege and request that my remarks be printed in the Journal.

Madam Speaker and members of the Assembly:

You know, I read a letter to the editor this morning and some individual was saying that it is a big joke down here

and we are not earning our \$90. Legislators are often criticized, but I think the legislative process is very thorough and I don't like to see it criticized.

In these closing days we are making some very major decisions. Now, there isn't a member in this legislative assembly that has not worked real hard and put in long days through this whole process and for someone to say now that we have to rush and get out of here, get things bundled up in a hurry, is wrong.

Let's do the job we were elected to do. Some of these bills that we are dealing with are going to take a two-thirds vote and that is very difficult. You know we talk about the legislature being a board of directors; sure, we are a board of directors, we are two boards of directors, one in each chamber. We meet separately and have big decisions to make.

Each party has a different philosophy on some measures. This is the way the process works and I like that process. I think the challenge is good, we need that. We all need to be challenged and it is good when the public criticizes us, but I do not like to see the unjustified criticisms come from within.

I have been proud of the floor leaders on both sides and both parties: the way they sat down and tried to work out the differences. Now, if you know of another process, let us hear it. Maybe we should all meet in joint session, but our process is open - the floor leaders in this chamber are under extreme pressure. They are before the cameras in the open. They can be quoted or misquoted, and they can be saying something that is not quite right at the spur of the moment.

I hope that we do not just scramble to get out of here. I hope we make these major decisions and we make them right. We know we are taxing people. We know we are taxing businesses, and we are spending money for education, etc. I hope in these closing days that we do not panic and say, "Let's get out of here because we are over sixty days." That is very important and I am confident that things will be worked out and we will try to be fair to businesses and to indivduals. Tax reform is taking place right now. That is very important and deserves some very, very close attention.

Dear Madam Speaker:

House Bill 1482 would repeal section 15-28-02 of the North Dakota Century Code, relating to rural resident membership on school boards. This section now provides that one or more school board members be "residents upon farms" within a given school district depending upon total district population, city population and assessed rural and city taxable valuation.

While there may be justification for removing as a basis for determining school board membership the assessed taxable valuation of urban and rural property within a district, I do not

believe the basic residency requirements contained in section 15-28-02 should be discarded.

The success of school district reorganization in this state during the past several decades was in large measure a result of rural cooperation and contribution effected by rural membership on school boards. Without the full participation of the rural population, reorganization would have failed and neither urban nor rural school systems would today be offering quality education. The fact is that consolidation of rural and urban school systems has resulted in modern facilities and comprehensive curricula which neither system could separately maintain.

In addition, primary and secondary schools are a central factor in the quality of North Dakota rural life. The importance of this fact should not be underestimated or disregarded.

Having reviewed the provisions of section 15-28-02 and recent United States Supreme Court decisions relating to voter equality, I believe existing law, for the most part, respects constitutional guarantees and does not discriminate against urban voters. Rather, rural membership has provided the necessary active participation by our rural population in school administration.

Because of my strong commitment to maintaining quality rural life and community for our citizens who choose it, I view House Bill 1482 as having a possible negative impact on the need to keep the basic framework which fosters cooperative school administration and voluntary reorganization.

Therefore, I veto House Bill 1482.

## STATEMENT OF PURPOSE OF AMENDMENT:

## Weather Modification Board

The salaries and wages line item is decreased by \$4,284 from the general fund. This will allow funds for the state to provide a two percent contribution to retirement on wages earned after July 1, 1983, and an additional two percent contribution amounting to a full four percent on wages earned after July 1, 1984. It also provides \$1,050 over the executive budget for health insurance premiums.

After the above adjustment, the appropriation is reduced by a budget adjustment of \$17,843 (two percent), of which \$14,454 is from other funds and \$3,389 is from the general fund. # REPORT OF CONFERENCE COMMITTEE

MADAM SPEAKER: Your Conference Committee to which was referred SB 2244 has had the same under consideration and recommends that the HOUSE RECEDE from its amendments as found on page 1826 of the House Journal and that SB 2244 be amended as follows:

    - 1. A nonprofit organization exempt from taxation under section 501(c)(3) of the Internal Revenue Code [26 U.S.C. 501(c)(3)]

- or a trust for the benefit of an individual or a class of individuals related within the degrees of kinship specified in subsection 2 of section 10-06-07 may own or lease farm or ranch land if that land is leased to a person who farms or ranches the land as a sole proprietorship, partnership, or a corporation allowed to engage in farming or ranching under section 10-06-07.
- 2. A nonprofit organization exempt from taxation under section 501(c)(3) of the Internal Revenue Code and actively engaged in the business of farming or ranching in this state on January 1, 1983, may continue to engage in the business of farming or ranching without interruption after January 1, 1983.
- 3. A nonprofit organization exempt from taxation under section 501(c)(3) of the Internal Revenue Code which owned farm or ranch land for the preservation of unique historical, archaeological, or environmental land prior to January 1, 1983, may continue ownership of such land without interruption after January 1, 1983.
- 4. A nonprofit organization exempt from taxation under section 501(c)(3) of the Internal Revenue Code [26 U.S.C. 501(c)(3)] may acquire farm or ranch land only by inter vivos or testamentary gift. A nonprofit organization exempt from taxation under section 501(c)(3) of the Internal Revenue Code must dispose of all farm or ranch land acquired in fee after January 1, 1983, not more than fifteen years after the date of acquiring ownership in fee.

SECTION 7. A new section to chapter 10-06 of the North Dakota Century Code is hereby created and enacted to read as follows:

Industrial and business purpose exception. A corporation which is not engaged in the business of farming or ranching may own or lease land used for farming or ranching, only when the land is necessary for residential or commercial development, the siting of buildings, plants, facilities, industrial parks, or similar business or industrial purposes of the corporation, or for uses supportive of or ancillary to adjacent nonagricultural land for the benefit of both land parcels. The farm or ranch land while not

being immediately used for any purpose of the corporation must be available to be leased by persons actually engaged in farming or ranching.

SECTION 8. A new section to chapter 10-06 of the North Dakota Century Code is hereby created and enacted to read as follows:

Reports of corporations not engaged in farming or ranching. Any business or nonprofit corporation not engaged in the business of farming or ranching which owns or leases a tract of land used for farming or ranching which is larger than twenty acres [8.09 hectares] in size shall file with the attorney general, prior to July 30, 1983, and within twelve months of any transaction involving the purchase, sale, or surface leasing of such farm or ranch land by that corporation, a report containing all of the following information:

- 1. The name of the corporation and its place of incorporation and, if a nonprofit corporation, a copy of its section 501(c)(3) exemption letter from the internal revenue service.
- 2. The address of the registered office of the corporation in this state and the name and address of its registered agent in this state.
- 3. The acreage [hectarage] and location listed by section, township, range, and county of all such land in the state owned or leased by the corporation and used for farming or ranching.
- 4. The date and method of acquisition or disposal of such farm or ranch land.

SECTION 9. EXPIRATION DATE. Subsection 4 of section 6 and section 7 of this Act are effective through June 30, 1985, and after that date are ineffective."

## POINT OF PERSONAL PRIVILEGE

REP. NOWATZKI: Madam Speaker: I rise on a point of personal privilege and request that my remarks be printed in the Journal.

I was the only member of the House majority party who signed this conference report, and I would like to state some reasons why I did and then why I think the amendments should be adopted and the bill passed.

The whole question that we're discussing here today relates to land ethics, the principle that land should be owned by private people, private ownership of land. You can go all the way back to feudal days to make a strong case for that. The reasons why I signed this report and why I think these amendments represent a reasonable compromise and, I think, are progressive in nature, and still protect the reasonableness of this so-called "private land ethics" that we are concerned about. Some of the reasons are as follows:

First of all, I think that Senate Bill No. 2244 taken as a whole does significantly improve the workability of the present corporate farming act of North Dakota. It allows the husband and wife to incorporate if they are farming. It allows a single person, be he a widow, a bachelor, or just a single person, to incorporate and to take advantage of the corporate farm structure and I think that is a significant improvement. Presently it requires three people to incorporate.

Another reason why I signed this report: Where it does differ significantly from the bill that was vetoed by the Governor as I interpret it, when studying this report and studying its amendments, from now on, under the provisions of this bill and the amendments that it contains, nonprofit 501(c)(3) trust can only accept land by will. They cannot rent lands, they cannot purchase lands. Furthermore, if they do accept land by will, the law as it would state in these amendments would indicate that these trusts would have to divest of their property within fifteen years.

And, thirdly, and perhaps the most important reason why I signed this report and why I urge the passage of these amendments and the bill, is that I think there is a moral responsibility to honor wills that were made in good faith in years past. I know of a number of people that have donated properties to Churches, universities, or wherever, significantly to the SOI(c)(3) group as defined by the present IRS code. These wills were made in good faith, not knowing that we were going to change the law as of today. I think that we have a right to honor those wills that were made in good faith and I think that is thoroughly just as important as the land ethics that we think of in terms of private ownership and, as I said earlier, a significant

change of these amendments from the vetoed bill puts people, attorneys, estate planners, whoever, it clearly puts them on warning that from today on, that property that is willed to these nonprofit charitable organizations of 501(c)(3) could do it only by will and they would have to divest within fifteen years. I think these points, taken together as a whole, plus the fact that we passed a study resolution that will study the whole issue of corporate farming in North Dakota as it pertains to the land ethic concept, the sociological impact, the economic impact; I think that, all of these things taken as a whole, these amendments represent a reasonable compromise. I think it improves the corporate farming bill, and I think these amendments are proper. I would urge they do pass.

# SECOND READING OF SENATE BILL

SB 2244: A BILL for an Act to create and enact six new sections to chapter 10-06 of the North Dakota Century Code, relating to applicability of the Business Corporation Act to the corporate farming law, to officers, directors, and shareholders of corporate farms or ranches, to an initial report, to the acquisition of farm or ranch land by certain nonprofit organizations, the application of the corporate farming law to certain business or industrial uses, and reporting requirements of certain corporations; to amend and reenact sections 10-06-07 and 10-06-08 of the North Dakota Century Code, relating to requirements to be met before a corporation will be allowed to engage in farming or ranching and reports that must be filed by farm or ranch corporations; and to provide an expiration date.
