MOTIONS

SEN. NOTHING MOVED that the Senate reconsider the action whereby SB 2187 was passed, which motion prevailed.

SEN. NOTHING MOVED that SB 2187 be rereferred to the Committee on Social Services and Veterans Affairs, which motion prevailed.

RECOGNITION

SEN. NOTHING ANNOUNCED to the Senate that Brenda Lee Bonogofsky, Miss Rodeo America, from Carson, N.D., is in the chamber and moved that a committee of two be appointed to escort her to the rostrum.

The motion prevailed, and the President appointed as such committee, Senators David and Krauter, who escorted Miss Bonogofsky to the rostrum.

The Bismarck Mounted Police, headed by Captain P. J. Curtis, are her honor guard.

SEN. NOTHING MOVED that the remarks of Miss Bonogofsky and Senators David and Krauter be printed in the Journal, which motion prevailed.

President Sands: It is my pleasure to introduce to the Senate of the state of North Dakota, Brenda Lee Bonogofsky, who is the daughter of James and Mary Lou Bonogofsky, who live on a ranch north of Carson. She was an honor student at the Carson high school where she participated in girls' basketball and was a cheerleader. She attended BJC and majored in public relations. She was Miss Grant County and then went on to become Miss Rodeo North Dakota. These were the stepping stones for her to become Miss Rodeo America.

On December fifth she was crowned Miss Rodeo America at Oklahoma City. On June thirtieth and July first Brenda Lee Bonogofsky and Richard Miller, mayor of Carson, will lead the parade at Springdale, Arkansas, for a state rodeo of the Ozarks. Kay Nelson, who is the pageant director of Miss Rodeo North Dakota accompanies Brenda Lee.

Brenda Lee will be at the Professional Rodeo Cowboys Association at Colorado Springs, Colorado, when she is not traveling around the United States to appear at functions.

It is my honor and pleasure to present to you Brenda Lee Bonogofsky.

Brenda Lee Bonogofsky: Thank you very much. I would like to thank the Bismarck Mounted Police for being my official escort; they are my official escort anytime I do come home to North Dakota, and I have just been at the big Denver rodeo and I can't say how much I appreciate North Dakota after being there.

They asked me to give my North Dakota speech which was given at the pageant. I competed against forty-one girls, and there they all gave a speech on their respective states to promote their states, as they would be promoting rodeo. You had to cram your home state into three minutes and this is what I did for North Dakota:

Now I know you've all heard the saying "he's a diamond in the rough", well that's how I feel about my home, North Dakota. Where I live in a state where the land has not been destroyed by overpopulation and cultivation, industry has not darkened our shining skies of the west, nor

polluted our rivers that are so pure. Whether you are standing on a butte or riding across the plains, you're sure to find a place just for you. Long famous as Rough Rider country, I've driven down our smooth Dakota highways and gazed upon rolling oceans of flowing grain. I've seen sunflowers with their heads tipped towards the sun and corn carefully cultivated and rotated to preserve our rich Dakota soil. North Dakota, isn't that cowboy and Indian country? You bet it is. You'll see vast herds of cattle grazing on the rolling plains and these herds are tended to by North Dakota's abundance of handy cowboys, cute ones too, I might add, like Brad Gjermundson, 1981 world champion saddle bronc rider. We're proud to have hosted another world champion in 1957, Mr. Alvin Nelson.

Now most of our land in North Dakota is still in the rough, natural state, untouched by commercialism. We're as natural as the International Peace Gardens, located on the North Dakota-Canadian border, and we're as natural as the rugged, painted Badlands that cut their way through the western end of our state. Here, our twenty-sixth President of the United States, Theodore Roosevelt, started his cattle ranches in the 1800's. He learned to understand the west, here, and often said that "If it wasn't for my experience in the Badlands, I would have never become president." We're as natural as the famed Red River Valley that with its rich, black soil has made us the bread basket of the world.

Now you may ask why we've chosen this uncomplicated lifestyle? Why, its for many reasons. Did you know that we have the longest female life expectancy? That's right ladies, seventy-seven years, and did you know we have the second lowest crime rate in America? We're not afraid to leave our doors unlocked or to greet people we meet on the streets. The people of North Dakota are a friendly, special breed, and I'm proud to be a part of that breed.

Forever and always wrote Clell Gannon, who was a North Dakota poet, "I shall love the land." Now this also expresses my personal feelings about my state, for I've stood and I've heard the first sweet meadowlark of spring and I've listened to the wind sing through the cottonwoods along the river bottoms where I ranch. I've ridden through the Badlands and I've felt the spirit of Teddy there, and I've seen the prairie roses blooming on the plains with what seems a message direct from God. These are truly precious experiences, and these are some of the reasons men like Louis L'Amour, who is a former North Dakotan and Teddy Roosevelt stand tall. Men who took the time to find the unhurried life where the crowds and crunch were just an unpleasant memory. Men who are admired for their sterling qualities that still seem to be like North Dakota, a diamond in the rough.

SEN. KRAUTER: Ladies and Gentlemen of the Senate. I wholeheartedly endorse the comments that Brenda Lee has made for this Assembly. Not only does Brenda Lee represent what a growing talent we have in North Dakota and the pursuit that she has followed, but I think that she's going to be a big plus for North Dakota and it's going to light up all the lights around North Dakota as a national figure. Let North Dakota be known as a state that's going to be recognized nationwide. Thank you, Mr. President.

SEN. DAVID: Mr. President and members of this body. I think it's such a distinguished pleasure for us today to have heard the remarks of Brenda Lee and I think we too ought to be awfully proud that Oklahoma and the rest of these United States had an opportunity to hear this young lady describe her feelings about North Dakota. I concur with what Senator Krauter had to say in reference to her and her accomplishments for this year, but it's the first time in many, many years that we've had young ladies participating in the Miss Rodeo America contest that we've come home with such a winner, and after having heard her today I'm sure, Mr. President, you and the members of this body will concur that she certainly is a winner.

SEN. NOTHING: Mr. President and ladies and gentlemen of the Senate. It's indeed a rare opportunity for us in the North Dakota legislature to honor one of our outstanding young people who has achieved an award that has brought national attention to our state. Sometime ago we adopted Senate Rule 407 and because of that we have not had the opportunity to honor individuals as often as we did, because, before, we didn't just limit it to national recognition. So, Miss Rodeo America 1983, we're proud and happy to have you here. This time, Mr. President, I know that she will be receiving a copy of the resolution, but she also may like to have a copy of the Journal of today and because of that I would ask that we have a recorded roll vote.

SB 2317: A BILL for an Act to increase or decrease the rate of sales, use, and motor vehicle excise taxes if projections made by the office of management and budget indicate the general fund balance will reach certain levels.

Sens. Maixner, J. Meyer and Reps. R. Anderson, Thompson introduced:

SB 2319: A BILL for an Act to amend and reenact subsection 2 of section 38-11.1-03, sections 38-11.1-04, 38-11.1-05, and 38-11.1-08 of the North Dakota Century Code, relating to oil and gas production damage compensation.  
Was read the first time and referred to the Committee on Natural Resources.

Sen. Nelson and Reps. Peltier, Sinner introduced:

SB 2320: A BILL for an Act to amend and reenact sections 2-06-14, 2-06-15, and 57-15-37.1 of the North Dakota Century Code, relating to mill levies of regional, municipal, county, or township airports and airport authorities.  
Was read the first time and referred to the Committee on Political Subdivisions.

Sens. Adams, Bakewell, Thane and Reps. B. Larson, Gorder introduced:

SB 2321: A BILL for an Act to amend and reenact section 41-09-28 of the North Dakota Century Code, relating to protection given buyers of goods and commission merchants selling livestock or agricultural products.  
Was read the first time and referred to the Committee on Agriculture.

Sens. Adams, Bakewell and Reps. Kent, O'Connell introduced:

SB 2322: A BILL for an Act to amend and reenact subsection 23 of section 20.1-01-02 and sections 20.1-01-17, 20.1-01-18, 20.1-01-19, and 20.1-01-20 of the North Dakota Century Code, relating to the definition of established road or trail and hunting on private lands.

Was read the first time and referred to the Committee on Natural Resources.

Sen. Barth introduced:

SB 2323: A BILL for an Act to amend and reenact section 57-38-29.1 of the North Dakota Century Code, relating to the energy cost relief credit; and to provide an effective date.

Was read the first time and referred to the Committee on Finance and Taxation.

Sens. Maixner, Kusler introduced:

SB 2324: A BILL for an Act to amend and reenact subsection 10 of section 38-18-05 and subsection 3 of section 38-18-06 of the North Dakota Century Code, relating to the definition of surface owner and the effect of a previously executed mineral lease or service lease in favor of the mineral developer.

Was read the first time and referred to the Committee on Natural Resources.

Sen. Matchie and Rep. Swiontek introduced:

SB 2325: A BILL for an Act to amend and reenact section 34-07-15 of the North Dakota Century Code, relating to the maximum hours of labor of minors under sixteen years of age.

Was read the first time and referred to the Committee on Industry, Business, and Labor.

Sen. Matchie introduced:

SB 2326: A BILL for an Act to create and enact a new section to chapter 37-17.1 of the North Dakota Century Code, to require disaster warning sirens in certain mobile home parks.

Was read the first time and referred to the Committee on Political Subdivisions.

Sen. Matchie introduced:

SB 2327: A BILL for an Act to amend and reenact section 57-38-42 of the North Dakota Century Code, relating to information at source returns for income tax purposes and to provide for a penalty for failure to file such returns.

Was read the first time and referred to the Committee on Finance and Taxation.

Sen. Stenehjem introduced:

SB 2328: A BILL for an Act to amend and reenact subsection 1 of section 30.1-10-01 of the North Dakota Century Code, relating to the renunciation of succession.

Was read the first time and referred to the Committee on Judiciary.

Sens. Lips, Dykshoorn introduced:

SB 2329: A BILL for an Act to regulate businesses that provide recovery and towing with storage operations; to provide for possessory liens, foreclosure and salvage disposal, private

trespass towing, and the reporting of unclaimed vehicles by towers; and to provide a penalty.

Was read the first time and referred to the Committee on Transportation.

Sen. Olson introduced:

**SB 2330:** A BILL for an Act to amend and reenact section 40-24-10 of the North Dakota Century Code, relating to the payment by general taxation of an improvement financed by special assessment.

Was read the first time and referred to the Committee on Political Subdivisions.

Sen. Lips introduced:

**SB 2331:** A BILL for an Act to provide for discretionary tuition waivers to be granted by the presidents of specified institutions of higher education under the direction of the state board of higher education.

Was read the first time and referred to the Committee on Education.

Sen. Moore introduced:

**SB 2332** A BILL for an Act to create and enact a new subsection to section 57-02-08.1 of the North Dakota Century Code, relating to the homestead credit and farm structures exempt from taxation; and to provide an effective date.

Was read the first time and referred to the Committee on Finance and Taxation.

Sen. D. Meyer and Rep. O. Hanson introduced:

**SB 2333** A BILL for an Act to amend and reenact section 4-34-08 of the North Dakota Century Code, relating to the assessment of cattle for the beef commission.

Was read the first time and referred to the Committee on Agriculture.

Sen. Lips and Reps. Horgan, Unhjem, Koski introduced:

**SB 2334** A BILL for an Act to amend and reenact sections 44-06-01 and 44-06-03 of the North Dakota Century Code, relating to the term of office and bonding requirements of notaries public.

Was read the first time and referred to the Committee on State and Federal Government.

Sen. Olson and Rep. Unhjem introduced:

**SB 2335** A BILL for an Act to repeal subsection 5 of section 14-03-17 of the North Dakota Century Code, relating to an application for a marriage license.

Was read the first time and referred to the Committee on Social Services and Veterans Affairs.

Sen. Thane introduced:

**SB 2336** A BILL for an Act to amend and reenact section 57-20-08 of the North Dakota Century Code, relating to tax receipts for property taxes paid by mail.

Was read the first time and referred to the Committee on Finance and Taxation.

Sen. Dotzenrod introduced:

SB 2337 A BILL for an Act to create and enact a new section to chapter 19-20.1 of the North Dakota Century Code, relating to the liability of the state; and to amend and reenact sections 19-20.1-03.2 and 19-20.1-04 of the North Dakota Century Code, relating to the proof of effectiveness and labeling requirements for an applicant seeking to register and/or license a fertilizer or soil amendment.

SB 2339: A BILL for an Act to require the director of the institute for regional studies of North Dakota state university to compile, publish, and distribute four general volumes of history in the series "The Centennial Heritage Series"; an agricultural history, a social history, a literary history, and a history of North Dakota native Americans; and to provide an appropriation.

Was read the first time and referred to the Committee on State and Federal Government.

Sens. Walsh, Christensen introduced:

SB 2340: A BILL for an Act to amend and reenact section 9-10-07 of the North Dakota Century Code, relating to contribution to damage awards by joint tort-feasors.

Was read the first time and referred to the Committee on Judiciary.

Sen. Heigaard introduced:

SB 2341: A BILL for an Act to amend and reenact section 37-01-25 of the North Dakota Century Code, relating to compensation and retention of status for national guard members, armed forces reserve members, or persons in federal noncivilian service who are public employees.

Was read the first time and referred to the Committee on Political Subdivisions.

Sens. Nething, Nelson introduced:

SB 2342: A BILL for an Act to provide for the issuance, sale, and delivery of water development bonds, southwest pipeline series; to create a sinking fund and other funds; to provide for the servicing and retirement of the bonds; to provide a continuing appropriation for the payment of the bonds; and to amend and reenact section 57-51.1-07 of the North Dakota Century Code, relating to the allocation of

oil extraction tax revenues; and to provide an effective date.

Was read the first time and referred to the **Committee on Appropriations**.

Sen. Heigaard introduced:

**SB 2343:** A BILL for an Act to create and enact a new section to chapter 35-03 of the North Dakota Century Code, relating to collateral real estate mortgages.

**SB 2344:** A BILL for an Act to amend and reenact sections 61-16.1-52 and 61-21-67 of the North Dakota Century Code, relating to the closing of noncomplying drains.

Was read the first time and referred to the **Committee on Natural Resources**.

Sens. Vosper, Adams, Tallackson and Reps. Nicholas, A. Olson, Kent introduced:

**SB 2345:** A BILL for an Act to create and enact a new chapter to title 6 of the North Dakota Century Code, relating to a beginning farmer loan guarantee program to be administered by the Bank of North Dakota; and to repeal sections 54-17-29, 54-17-30, and 54-17-31 of the North Dakota Century Code, relating to an industrial commission loan guarantee program for seller-sponsored loans between landowners and beginning farmers, the procedure on default of a guaranteed loan, and the establishment and maintenance of an adequate guarantee fund through an appropriation from the lands and minerals trust.

Was read the first time and referred to the **Committee on Agriculture**.

Sens. Maixner, Waldera, David and Reps. Lardy, Knudson, Thompson introduced:

**SB 2348:** A BILL for an Act to create and enact a new section to chapter 61-04 of the North Dakota Century Code, relating to the establishment of an industrial use fee for use of water from the Missouri River.

Was read the first time and referred to the **Committee on Natural Resources.**

Sens. Vosper, D. Meyer and Reps. W. Meyer, O. Hanson introduced:

**SB 2349:** A BILL for an Act to create a new section to chapter 36-15 of the North Dakota Century Code, relating to the administrative enforcement of the provisions of that chapter; and to amend and reenact section 36-15-21 of the North Dakota Century Code, relating to calfhood vaccinations against brucellosis; and to provide a penalty.

Was read the first time and referred to the **Committee on Agriculture.**

Sen. Lashkowitz and Reps. Retzer, Aubol introduced:

**SB 2350:** A BILL for an Act to amend and reenact section 65-05.2-02 of the North Dakota Century Code, relating to the amount of supplementary workmen's compensation benefits; and providing that the premium rate may not be increased during the 1983-1985 biennium.
