SB 2047: A BILL for an Act to create and enact two new sections to chapter 57-15 of the North Dakota Century Code, relating to the consolidation of school district mill levies into a general fund and a special fund levy; to amend and reenact sections 15-34.2-06, 15-39.1-28, 15-40.2-12, 15-45-01, 15-59-08, 32-12.1-08, 32-12.1-11, 40-55-08, 40-55-09, 52-09-08, and 57-15-14 of the North Dakota Century Code, relating to boarding and lodging of high school students, a teachers' retirement fund, tuition for students in grades seven through twelve, kindergartens, special education, an insurance reserve fund, judgments against school districts, recreation centers, old-age survivors' fund, and tax levy limitations; and to repeal sections 15-20.1-08, 57-15-15, 57-15-18.1, 57-15-18.2, 57-15-49, 57-15-52, and 57-15-52.1 of the North Dakota Century Code, relating to school district mill levies for vocational education, rental expenses, unemployment compensation, libraries, and communication and schoolbus costs.

SB 2197: A BILL for an Act to amend and reenact subsections 2 and 5 of section 39-04-19 and section 39-04-24 of the North Dakota Century Code, relating to motor vehicle registration fees, and the registrar determining the weight of a motor vehicle.

On page 1 of the engrossed bill, line 1, after the words "A BILL" delete the remainder of the bill and insert in lieu thereof the following: "for an Act to amend and reenact subsections 2 and 5 of section 39-04-19 of the North Dakota Century Code, relating to motor vehicle registration fees.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF THE
STATE OF NORTH DAKOTA:

SECTION 1. AMENDMENT. Subsections 2 and 5 of section 39-04-19 of the 1981 Supplement to the North Dakota Century Code are hereby amended and reenacted to read as follows:

2. Motor vehicles required to be registered in this state shall be furnished license plates upon the payment of the following annual fees; however, if a motor vehicle first becomes subject to registration other than at the beginning of the registration period, such fees shall be prorated on a monthly basis. The minimum fee charged hereunder shall be five dollars:

In addition to the fees required in this subsection and section 49-18-32, all motorbuses used for the transportation of persons for hire over the highways of this state which have a seating capacity of more than seven passengers shall pay an annual additional license fee of twelve dollars for each passenger capacity in excess of seven. Motor passenger buses operating exclusively within the corporate limits of any city shall not be required to pay this fee.

- b. Schoolbuses, buses owned and operated by religious, charitable, or nonprofit organizations and used exclusively for

religious, charitable, or other public nonprofit purposes, and trucks or combination trucks and trailers, including commercial and noncommercial trucks, except those trucks or combinations of trucks and trailers which qualify for registration under subsection 5:
