Dear Lieutenant Governor Sands:

It is a pleasure to use this opportunity to correspond with you. It is an even bigger pleasure to deliver to you Illinois Senator John Grotberg (as in, "Take John Grotberg, please"). As you are probably aware, John is the black sheep of the Grotberg family. We in Illinois heartily commend Senator Perry Grotberg's tolerance of his brother's wayward political philosophies.

The great states of North Dakota and Illinois have a good deal in common: both states are highly agricultural and have large coal and oil reserves. Both states were explored by Lewis and Clark. In 1818, the United States obtained the northeastern portion of North Dakota by treaty with Great Britain. That same year, Illinois was admitted to the Union.

RECOGNITION

SEN. NELSON MOVED that a committee of two be appointed to escort Senator John Grotberg of the Illinois Legislature, and brother of North Dakota Senator Perry Grotberg, to the rostrum, which motion prevailed.

REMARKS OF SENATOR JOHN GROTBORG

Thank you, Mr. President, House of Lords, distinguished guests, and fellow Senators. Mr. President, I have a piece of paper here that I would like for you to convey to the distinguished Governor of North Dakota from Landslide Thompson, which entails in brief the 1.2 billion dollar problem that the state of Illinois General

Assembly is facing and if you would convey it to him, Mr. President, I would appreciate it.

Now those of you who have taken lightly to the introductions should always remember that Perry and I and our brothers and sisters and many of you were born in those great days before we had a department of Human Resources, a department of children and family services, social workers, university free gifts, but what we had was a way to grow up which is no longer too popular--you ran away from home. You voted with your feet and it didn't turn out all that bad, did it? Perry, where did you go? Come and stand beside me, I'd be honored. May I let my brother share this with me, and Perry will agree with me, that it is only fair that you are now tinkering with the laws of North Dakota because we tinkered to get through the 30's and the 40's and the late 20's, and we became a generation of tinkers and a family of tinkers, but the thing we learned that they haven't learned today that makes a good tinkerer is: you never throw away any of the parts and that is the difference. You save what it takes to put it back together.

In the Illinois General Assembly, House and Senate alike, I will only take a couple of moments to tell you about it, we have shared some of it with some of you individually, but we have fifty-nine Senators and one hundred eighteen House Members. Our Senate districts are two hundred thousand and the House districts are one hundred thousand or two single-member districts within each Senate district. I just checked this morning, we have one hundred sixty legislative days in the last biennium but that is spread out on a substantive year and on the off-year we do only appropriations and revenue; but this is a substantive year that is spread out over about eight thousand bills over a two-year period.

In the perspective of what you ladies and gentlemen work so hard for and earn every nickel of it, some people think we are paid too much, but we make twenty-eight thousand dollars a year and we have an office and a secretary in Springfield, each of us Senators and each House member has an office and shares a secretary full time the year around. We have a home office allowance that has been for a number of years seventeen thousand dollars and for that you can't feed your relatives on that, but for that you are allowed to run a rather substantial home office; and if you recognize that the Senate district is about half the size of a Congressional district so it's not unfair that something like that should be done.

I think in that perspective you should do that much for yourselves because it was only twelve years ago that the Illinois Senate had lockers, had a secretarial pool, and no place to do the peoples' business; the people expect so much for so little, and I think I understand some of that, also that these are very difficult days. They are difficult in Illinois.

I believe that the honor of being a Senator or a Representative in any state in the Union is an extreme responsibility that is handed to you by the people. These seats don't belong to anybody---you get a short lease on them, and if you pay the rent you get to keep them, and like every other job, this one is a little more exciting, and not unlike a sled dog, the only job in the world that is worth having is the lead dog, because he gets a change of scenery once in a while and that happens, I believe, to be one of the prerogatives and one of the exciting challenges of being a legislator.

Yes, Illinois, like you, is out of money. We have a June thirtieth adjournment date. We need three hundred million dollars before June thirtieth, and we need a billion the following year that is not in the coffers now. Our governor has suggested a forty percent increase in our income tax and a package of other taxes. The problem is he can't find a sponsor for the bills. He can't find one in either party. It is interesting that in this time---and I hope you share this philosophy with those of us who have campaigned for so many years and we run around and make promises to outdo the opposition and all those things---that people have asked for less government for so long and are finally getting it.

We took off two percent in December for the six months remaining in this period, and you can hear them screaming to the West Coast and the East Coast. They haven't seen anything yet. We are going to take off another two percent in the next ninety days, and we'll see how much less government Illinois can stand, but that seems to be what the people want until it's their ox that is being gored, etc., and ad infinitum, and they line up.

I enjoyed going to your Appropriations Committee meeting this morning and listening to the same dialogue that we get all over every legislature, I presume. We have eleven million people, it's no surprise to you, I want to compliment the way you run the shop, Mr. President, and your Minority and Majority Leaders. Incidentally, I have not been invited to the Majority Leader's office, and I don't know where the protocol went wrong there, but be nice to the minority. I am living testimony that some day you can be one, and I'd be glad to stop by your office. Your decorum is so great, you do the peoples' business with dispatch, Mr. President, and I think I understand where Illinois went wrong.

Several of you have visited our chamber, I know my brother has, I know Jens Tennesos has, and we walk around and conduct our business all during debate. Sometimes you know who is talking, sometimes you don't know, sometimes you don't care, but I think that goes back to Abe Lincoln, and I am proud to sit in the land of Lincoln and sit in his shadow, really, in Springfield, it is. It is an intense honor for those of us who went to the one-room school out north of Valley City and dreamed of Abraham Lincoln and Americanism. But Abe Lincoln, to prevent a quorum one day in

the old court house at Vandalia, took off out the window, dropped two stories and disappeared and, of course, there was no quorum. And that spirit has been in the Illinois legislature ever since.

You know Abe did quite a few funny things, and he is not known for all of his sense of humor, but one of the things I would like to close with in a stolen five minutes of your precious time is to admonish each of you of his famous words which I keep in my wallet at all times. You are going to start getting the hate mail pretty soon. That's how I judge my effectiveness. Not by the good mail but by the hate mail, and the hate mail will come, but as he was President, he said, "If I were to read, much less answer all attacks made upon me, this shop might as well be closed for any other business. I do the very best I can and I mean to keep doing so to the end. If the end brings me out right, what is said against me won't amount to anything. If the end brings me out wrong, ten angels swearing I was right would make no difference." And that, again is the Illinois spirit, it's the spirit of all legislators everywhere. Please come to Illinois when you can, and share our hospitality, each and every one of you. Thank you very much.
