1. A member insurer may offset against its premium or income tax liability to this state an assessment described in subsection 8 of section 6 to the extent of twenty percent of the amount of the assessment for each of the five calendar years following the year in which the assessment was paid. If a member insurer ceases doing business, all uncredited assessments may be credited against its premium or income tax liability for the year it ceases doing business.
2. The association shall pay any sums acquired by refund, pursuant to subsection 6 of section 6, from the association which have theretofore been written off by contributing insurers and offset against premium or income taxes as provided in subsection 1, and are not then needed for purposes of this Act, to the commissioner. The commissioner shall deposit these sums with the state treasurer for credit to the general fund of this state."

POINT OF PERSONAL PRIVILEGE

SEN. NETHING: Mr. President: I rise on a point of personal privilege and request that my remarks be printed in the Journal.

Mr. President, ladies and gentlemen of the Senate: I was absent from the Senate yesterday because I was attending a meeting in Washington, D.C., and I would like to give you a summary of the reasons for my absence.

Back in July of 1982, President Reagan appointed me to the Advisory Commission on Intergovernmental Relations. This is a commission which was established in 1959 and consists of representatives from the United States Senate, United States House, cabinet officials, citizens, three citizen members, four governors, three mayors, three county commissioners, and three legislators. I am one of the three legislative members of that commission.

As an outgrowth of this appointment, I was recently invited to serve on a national advisory panel to the Advisory Commission on Intergovernmental Relations study dealing with "The States and Distressed Communities Project," and it was for that reason that I was in Washington yesterday.

This panel consists of four elected officials from the United States: Senator John Kelly from Michigan, who is chairman of the Senate committee on corporations and economic development; Mayor Thomas Moody from Columbus, Ohio; the Honorable Wilson Riles, Jr., who is a city council member from Oakland, California; and myself, representing the elected officials. In addition, this panel consists of three technical experts: Dr. Renee Berger, who is a consultant in Washington, D.C.; Dr. Harold Hovey, who is a consultant in Arlington, Virginia; and Mr. James Solem, the executive director of the Minnesota Housing Authority in St. Paul, Minnesota. Both Dr. Berger and Dr. Hovey are consultants in the area of state and local governments.

The project that we are reviewing is entitled "The States and Distressed Communities." Since 1979, the Advisory Commission on Intergovernmental Relations has been monitoring the activities of the states in providing targeted assistance to distressed communities under a grant from the Department of HUD. This is the final year of this project and we are dealing now in a review of the project in three areas. The first is the issues and trends in state aid to distressed communities. Basically, it's an overview of the issues and trends which state governments are confronted with in their efforts to target aid to distressed communities. An example of targeting aid, and what we have done in North Dakota would be to provide impact aid in the communities where we are having energy development. The basic examination of the project consists of three areas. The first is the political and economic factors at the national level which constrain or enhance the capacity of state governments to provide targeted assistance. The second is a look at the full range of

state development programs from housing and capital improvements to development finance and transportation. The third is the issues the states face in targeting state aid to distressed communities.

The second part of the program is the implementing of the program into five policy areas. These consist of housing, economic development, community development, fiscal reform, and enhancing local capabilities.

The third part of the project is developing model state legislation or suggested state legislation for the states to follow should they find the need or the desire to enact legislation which will provide state aid to distressed and targeted communities.

Mr. President, ladies and gentlemen of the Senate, this is the scope of the panel's efforts. We will be meeting again in September to review the status of the study and particularly the proposed samples of suggested state legislation, and there is talk of a one-day meeting after that to grant final approval. I do apologize for missing, at this stage of the session, because it's important that all of us be here all of the time; however, I also feel that when we do have a chance to represent North Dakota in capacities where we have had little opportunity before, I think it is worthwhile, and I hope that the project that we're working on and the input that I have, particularly from that of a rural state, will be beneficial in the future. Thank you.
