There are federal payments to other states for care and treatment, however, at this time there has been no money allocated by the Federal Government for such payments to North Dakota. We do anticipate that starting this billing process, actively negotiating for a contract, and defining the Federal Government's responsibility, will result in more income to the state in subsequent federal fiscal years. We would hope that by the end of the 1985/1987 biennium, substantial income would result from the administrative costs of such a program reflected in this fiscal note. Without appropriate start up resources we would be unable to effectively develop and implement such a program. We realize that up front costs will not be immediately offset by revenue produced.
