Mr. Speaker, everybody here today, I assume, received these two sheets of yellow paper, long sheets of yellow paper on their desk, entitled Satire Concurrent Resolution No. 4444 and Satire Bill No. 2003. The second one, the Satire Concurrent Resolution No. 4444, is purportedly introduced by all members of the Forty-ninth Legislative Assembly. As one of the members of the Forty-ninth Legislative Assembly, I wish to arise and state my personal views on this.

I called the Legislative Council and asked if this was done in any sort of seriousness. I found out from the Legislative Council that this was, indeed, prepared by them, typed up and duplicated by the Legislative Council, but I guess that it was offered to us in some type of humor.

Senate Concurrent Resolution No. 4444 asks for some change in our Constitution to delegate the judicial and legislative powers of this body to Judge VanSickle and to delegate the executive powers of government to John Richardson, the head of the State Board of Higher Education.

This resolution I find not only to be contemptuous but disrespectful of two fine public servants, and as a member of the Forty-ninth Legislative Assembly, I object that I

would be used on this type of resolution, whether it's done in satire or in seriousness.
