## SENATE AMENDMENTS TO ENGROSSED HB 1167

Page 1, line 1, after "sections" insert "39-01-02,"

Page 1, line 3, after "to" insert "the display of official number plates and window decals on state vehicles,"

Page 1, after line 9, insert:

"SECTION 1. AMENDMENT. Section 39-01-02 of the 1989 Supplement to the North Dakota Century Code is amended and reenacted as follows:

39-01-02. Motor vehicles owned or leased by the state to display ~~name on side of vehicles~~ official number plate - Exceptions - Penalty. All motor vehicles owned and operated by the state, except the official vehicle for use by the governor, must ~~have displayed on each front door the words NORTH DAKOTA.~~ The words must be in letters four inches (10.16 centimeters) in height. Two and one-half inches (6.35 centimeters) directly below those words there must be printed in letters one and one-half inches (3.81 centimeters) in height the name of the state agency owning or leasing the motor vehicle. The width of the display required by this section must be proportionate to the required height. The color of the lettering must be in clear and sharp contrast to the background. The state highway patrol and all peace officers of this state shall enforce this section display distinctive official number plates and window decals designed by the director that identify it as a state fleet vehicle. The state auditor, in the course of spot checking or verifying the inventory of any state agency, shall include in the auditor's report to the governor and the legislative assembly any instance of noncompliance with this section that comes to the auditor's attention. The above requirements do not apply to vehicles operated by the attorney general's office, the bureau of criminal investigation, or game and fish department game wardens, the highway patrol, vehicles used for drivers education at state institutions, or vehicles used principally in juvenile, parole, and placement service, selected cars or vehicles of the state penitentiary approved by the director of institutions, vehicles owned and operated by any entity located upon the international boundary line between the United States of America and Canada used and maintained as a memorial to commemorate the long-existing relationship of peace and good will between the people and the governments of the United States of America and Canada and to further international peace among the nations of the world, or to any truck owned by any state agency. A passenger motor vehicle bearing official plates must be in compliance with this section. The administrator of any state agency who uses or authorizes the use of a motor vehicle which is not marked as required by this section is guilty of a class B misdemeanor work. The state highway patrol and all peace officers of this state shall enforce this section."

#### SENATE AMENDMENTS TO HB 1282

Page 1, line 1, after "A BILL" replace the remainder of the bill with "for an Act to create and enact a new section to chapter 15-21 of the North Dakota Century Code, relating to the waiver of conditions for accreditation and approval; and to repeal section 15-41-26 of the North Dakota Century Code, relating to the waiver of conditions for accreditation and approval.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. A new section to chapter 15-21 of the North Dakota Century Code is created and enacted as follows:

Waiver of conditions for accreditation and approval. The superintendent of public instruction may waive any conditions for accreditation and approval imposed by statute for a reasonable length of time, provided the waiver encourages innovation or permits experimentation and provided the plans and purposes document the potential for an improved program. The superintendent may waive the

conditions only upon the concurrence of a majority of a waiver committee composed of one person appointed by the North Dakota education association, one person appointed by the North Dakota council of school administrators, and one person appointed by the North Dakota school boards association.

SECTION 2. REPEAL. Section 15-41-26 of the North Dakota Century Code is repealed."

#### REMARKS BY THE HONORABLE BYRON DORGAN, UNITED STATES CONGRESSMAN

Thank you very much for that warm welcome and thank you very much for the invitation to come and address you today. As I walked in the door, I met a young man that I want to call your attention to. One of the real privileges of serving in the Congress is to be able to each year appoint young folks to our military service academies. We have had some wonderful young men and women from North Dakota go to these academies. As I walked in the door I found one of the young men that I appointed this year to West Point, Mr. Paul Johnston from Forest River, North Dakota, right in the back, so please greet Paul for me. Paul will be attending West Point beginning this Fall.

I understand that I am being squeezed in here just in front of the state horse later this afternoon; we have some of that legislation in the U.S. Congress as well, as you know. I try to keep abreast of what you are doing here through the newspapers, and it has appeared to me to have been a relatively quiet session. I guess I have gotten fifty or one hundred letters from North Dakotan's saying that they would "get me" if I voted wrong on Sunday opening. I wrote back to all of them and said I think I will be OK on that issue, and you probably have received letters about Lawrence Welk, which may make us even.

I, when I served in the Executive branch in this building, never fully understood or appreciated the Legislative function. I say that because there is no place for anybody in the Legislative function to hide. When you serve in the Legislature, on every issue, vote after vote, it is "yes" or "no". No "maybe", or "no, I don't have my mind made up", or "I need more time". It is "yes" or "no" then on that question, and I have never fully appreciated that until I actually served in a Legislative body. Now I fully understand and appreciate the difficulty of the work the North Dakota State Legislature does, day after day when they are in session.

When I went to Congress, Tip O'Neill was speaker, and one of the stories in Congress was that Tip O'Neill one day had a piece of legislation that was very important to him as speaker. He went down on the floor of the House to Congressman Donnelly from Massachusetts and put his arm around Congressman Donnelly and said, "Brian, old pal, on this one I really need you." Congressman Donnelly looked at Tip and said, "Tip, the problem is you are not right on this one." Tip looked at him and said, "Brian, when I am right, I don't need you." And so the Legislative process works. It is not so easy as it looks, and I know that even as there is partisan division and debate between parties and within parties, everyone here shares the same goal for our state. Different methods, perhaps, but the same goal. I would like to mention today a couple of things that I have been working on that I think will work hand-in-hand with some of the things you are working on for North Dakota.

All of us understand the challenge we face. We have lost upwards of forty or fifty thousand North Dakotans in recent years, moving away from our state.

That saps our economic strength in North Dakota. We understand the challenge of trying to turn that around. There are some things we can do something about and some things we can not. We can not make it rain, but it is going to rain again; we know that. We probably can not affect much, in this chamber, the price of oil or the price of wheat, although we can work on the price of grain on the edges in the political system; but there are some things we can do, and some things that you are working on. Vision 2000; which I think set a course for this state and a framework for debate that makes a lot of sense, and Growing North Dakota; the Democrats and Republicans working together to develop a framework for progress. They make a lot of sense to me. I am introducing this week in Congress the Rural Development Investment Zone Bill, which is an attempt, I think, to work with what you are doing to stimulate new opportunities and new development in rural America. One of the interesting things about economic distress and economic blight is, whenever they discuss it, they are talking about the inner cities and they are talking about the symptoms of unemployment and poverty; President Bush is pushing an Urban Enterprise Bill; classic symptoms of poverty and unemployment. Well, we have economic distress in rural America, but we don't exhibit the classic symptoms. We don't have much unemployment in North Dakota. If people can't find a job, they move. They just drive out of state and look for work elsewhere. So I am introducing legislation similar to the Urban Enterprise Zone that provides a ten percent tax credit on qualified wages for new jobs moving to or growing within the state, a ten percent investment tax on machinery and equipment that qualifies, using a different set of symptoms. The symptoms are outmigration. Outmigration also represents a symptom of economic distress; a symptom that applies to rural America. If we can move legislation that describes outmigration and jobs lost in areas of rural America, then I think we can coordinate that approach at the Federal level with the approach that you are working on in the State Legislature. We can make some changes in a meaningful way that will develop a stable employment base and economic opportunity in the years ahead.

This week, Congressman English from Oklahoma and I are requesting of the GAO an evaluation of all the areas of the Federal Government where they do concentrated or centralized information processing. We are doing that because the Federal Government is now paying premium wages in three of the largest cities in the country because of the extraordinary cost of living in those cities. If we have to pay premium wages in some of the largest cities at the Federal level, why don't we find out what kind of processing jobs we are doing there and see if we can save money for the Federal Government by moving some of those information processing jobs to rural America. We hope by getting the information from the Government accounting office, we can find a base of opportunity and a base of targets that we can use in the years ahead to move additional information processing jobs to this state.

Another area that is a troublesome area to all of us is health care in rural America. We have lost two hospitals in North Dakota, Beach and New Rockford, in recent months. Another hospital has no doctors, and a couple of other hospitals are on the edge with very serious troubles. In the last two years, I helped write the program called EACH, a central access to community hospitals representing a program that is the first step to try to assist communities threatened with the loss of hospitals. I know that you have passed some legislation in this session that will allow the State Department of Health and Consolidated Laboratories to apply for some grants under the EACH program to help respond to some of the critical health care issues as well. Access to health care is critically important in rural America. We hear scandals and exposes on television in the cities if an ambulance was fifteen minutes late or took a wrong turn. But when you are forty miles from the nearest hospital, you are not talking about fifteen minutes or a wrong turn; you are talking about, in some cases, the difference between life and death, and that is why access in rural hospitals is so critically important.

As we face these challenges, and indeed they are challenges, because this state is suffering from some serious economic problems, we can it seems to me, wring our hands and continue to fret and worry, or we can decide to roll up our sleeves and get to work. I get the feeling that there is a spirit in this state, a bipartisan spirit of understanding and cooperation, that all of

us know what needs to be done. We may differ somewhat in methodology, but we all understand the goal. The goal is the North Dakota people expect all of us to work together in a coordinated way; in a partnership of sorts, between legislators at the state level and legislators at the Federal level, to see if we can put this system back on track for rural America. John F. Kennedy used to say that every mother wished her child would be able to grow up to be President, as long as they didn't have to get involved in politics. We all understand what he meant by that story, but I think politics is an honorable undertaking in this country. The process of politics, the process of making political decisions in a body like this, is one that I am enormously proud of. I never fail to describe to groups that I speak to, when I have the opportunity, the record that I think is developed from this Legislative body in the years that I was here watching it in the Executive Branch, and in the years since. A record of unblemished honesty; a record of hard work; of dedication to the kinds of causes that are important to our state. I am proud of what you do, I wish you well and I know that in a small period of time you are trying to cram a great deal of legislation through that you think is good for the state. God bless you and good luck to you. Thank you very much.
