RULES FOR DECORUM IN THE HOUSE CHAMBER

SPEAKER MARTIN ANNOUNCED that the Rules for Decorum in the House Chamber would be printed in the Journal.

RULES FOR DECORUM

1. No food is permitted on the floor of the House when the House is convened.
2. Pictures, including video camera taping, are not permitted to be taken any time, except by the press, house, and caucus employees or designers.
3. No one is permitted to sleep or rest in a prone position on the seats which line both sides of Memorial Hall between the House and Senate Chambers.
4. Every member must vote, if they are in the House Chamber, during a roll call vote.
5. When a Roll Call vote is taken, every member shall be in their seat and register their own vote, or call out their name and vote in a voice loud enough for the Speaker to hear. The Majority and Minority Leaders and their assistants are exempt from the provisions of this rule.
6. During debate, members are to be attentive and quiet, and the noise behind the rail shall be held to a minimum.
7. No member shall have more than one guest seated with the member on the floor at any one time.
8. No one is permitted to visit or lean over the back railing.
9. The Sergeant-at-Arms shall clear the floor of the House Chamber in front of the railing of all persons, except legislators, legislative employees, legislative guests, former members of the Legislative Assembly, and members of the press, during the time period commencing thirty minutes before the House convenes on any legislative day until the House recesses for that calendar day.
10. Tour groups will not be allowed at the front desk area.
11. Legislators and employees shall be suitably attired.

12. When a legislator is speaking, the Sergeant-at-Arms will not allow guests to enter that section.
13. When the Speaker is putting the question, no member shall walk out of or across the floor of the House.
14. When a member is speaking, no person shall pass between the person speaking and the chair.
15. A member desiring to speak shall rise and respectfully address the Speaker and shall remain in place before proceeding to speak until recognized by the chair.
16. Visitors sitting in lower tier of seats in House balcony shall not touch, lean over, place objects on, or put their feet on brass railings.
17. While the House is convened, no person shall read newspapers or other large publications in an unfolded and conspicuous manner.
18. All persons shall wear identification badges while in the House Chamber or in the employ of the House.
19. Any member seeing a violation of these directives, or who has a question or problem, should advise the Sergeant-at-Arms or an assistant as soon as possible.
20. All materials placed on desks must be authorized by a House member or individually addressed to each member.
21. House Rule 306 - No member may speak more than twice on the same subject except person carrying the bill, chairman, or floor leaders.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. Definitions. As used in sections 1 and 2 of this Act:

1. "Firearm" has the meaning given in 18 U.S.C. 921 [Pub. L. 90-351; 82 Stat. 197].
2. "School property" includes all school land, buildings, structures, facilities, and school vehicles whether owned or leased by a school district, and the site of any school-sponsored event or activity.

SECTION 2. Possession of a firearm - Prohibitions - Exceptions.

1. Each school board shall by resolution prohibit the possession of a firearm by a student on school property and at school functions and provide for the punishment of any student found to be in violation. Punishment may include suspension from school or expulsion for a period up to twelve months. Before expelling a student, a school board shall, within ten days of the student's suspension, provide the student with a hearing before the full school board at which time the school board must take testimony and consider evidence, including the existence of mitigating circumstances. A school board that expels a student under this subsection may provide educational services to the student in an alternative setting.
2. Actions taken under this section must be in accordance with chapter 15-59 and the Individuals with Disabilities Education Act [Pub. L. 911-230; 84 Stat. 121; 20 U.S.C. 1400 et seq.].
3. This section does not apply to any student participating in a school-sponsored shooting sport, provided the student informs the school principal of the student's participation and the student complies with all requirements set by the principal regarding the safe handling and storage of the firearm.

SECTION 3. AMENDMENT. Subsection 13 of section 15-29-08 of the North Dakota Century Code is amended and reenacted as follows:

13. SB 2447: A BILL for an Act to amend and reenact sections 45-11-02 and 45-11-04.1 of the North Dakota Century Code, relating to the content and renewal of fictitious name certificates filed with the secretary of state.

Was read the first time and referred to the **Government and Veterans Affairs Committee.**

SB 2454: A BILL for an Act to prohibit female genital mutilation; and to provide a penalty.

Was read the first time and referred to the **Human Services Committee.**

SB 2479: A BILL for an Act to create and enact a new section to chapter 6-08 of the North Dakota Century Code, relating to the consolidation of offenses for dishonored checks.

Was read the first time and referred to the **Industry, Business and Labor Committee.**

SB 2480: A BILL for an Act to amend and reenact subsection 2 of section 26.1-36-08 and paragraph 3 of subdivision e of subsection 2 of section 26.1-36-09 of the North Dakota Century Code, relating to copayments for treatment of substance abuse outside a preferred provider network.

Was read the first time and referred to the **Human Services Committee.**

SB 2501: A BILL for an Act to create and enact a new subsection to section 65-05-28 of the North Dakota Century Code, relating to aggravation of a work-related injury for purposes of determining workers' compensation benefits.

Was read the first time and referred to the **Industry, Business and Labor Committee.**

SB 2518: A BILL for an Act to create and enact a new subsection to section 57-01-02 of the North Dakota Century Code, relating to the tax commissioner's power to publish names of taxpayers who have not presented for payment state warrants issued for tax refunds.

Was read the first time and referred to the **Finance and Taxation Committee.**

SB 2521: A BILL for an Act to provide for landowner immunity from liability for injuries incurred while using a road located on the landowner's property; and to declare an emergency.

Was read the first time and referred to the **Agriculture Committee.**

SB 2523: A BILL for an Act to amend and reenact subsection 5 of section 25-03.1-43 of the North Dakota Century Code, relating to the confidentiality of records of treatment facility patients.

Was read the first time and referred to the **Human Services Committee.**

SCR 4022: A concurrent resolution urging Congress to enact legislation allowing an income tax deduction or credit for health insurance premiums.
