POINT OF PERSONAL PRIVILEGE

REP. CLAYBURGH: Mr. Speaker: I rise on a point of personal privilege and request that my remarks be printed in the Journal, which request was granted.

REMARKS OF REPRESENTATIVE CLAYBURGH

Mr. Speaker and members of the assembly, I believe it is important to comment on certain statements made here during debate on the appropriation bill for Higher Education. To erode public confidence in our two largest universities hurt unfairly these institutions, all of higher education, some very capable dedicated individuals, and indeed, the entire state of North Dakota.

In a calm, objective, and thoughtful review of this issue, I hope we will all agree:

First, the legislature allowed and indeed authorized transfers to be made within the state appropriated budgets. Here is wording from the bill passed by this House and the Senate in 1993: "The legislative assembly recognizes the appropriations in Section 1 may be insufficient to provide for both full funding of faculty and staff positions and for 1994-95 salary adjustments. Therefore, it intends that the Board of Higher Education take such action as it considers necessary to allocate the funding to maintain quality academic programs."

The legislature directed that "quality academic programs" be the priority! Also in the bill, the legislature gave the board the authority to "make such transfers between line items in its appropriations as may be determined necessary by the board for operations of the institution or agency."

There cannot be any misunderstanding of what the 1993 legislature authorized and directed.

Second, the funding transfers as authorized were not kept a secret. To the contrary, they were well-publicized in the media and not one complaint is on record made by the interim budget committee. They had this information.

Ladies and gentlemen of the House, I have at my desk a copy of the state auditor's most recent audit of the University of North Dakota. The auditors who work for us found nothing wrong, nothing sloppy, and nothing improper. In fact, the record will show for a decade or more, the auditors have been very pleased and complimentary on the way fiscal matters are handled at the University of North Dakota. I will provide a copy of this audit to anyone who is interested. As we all know, these audit reports are made to our interim audit and fiscal review committee.

Yes, as was stated on the floor last week, a growing percentage of the total budget for the two teaching and research universities is from sources other than general funds. This has been encouraged by past legislatures. The legislature has wisely recognized that universities are complex operations. The two large universities are forced to meet national competition for individuals who have the rare combination of having both teaching and research strengths. When we lose this type of resource to another state, it is not just the institution who loses, but the entire state. These individuals provide our highest potential for economic development and new job and wealth creation to benefit our entire state. UND and NDSU have both lost these types of individuals over the past biennium in spite of the best efforts of our administrators to keep them here.

My fellow House members, since statehood, the citizens of our state have given education and educational opportunities a high priority. This is a badge of honor for our state. The graduates of our institutions of higher learning have achieved in competition with graduates of universities across this nation, and have done so with distinction. We owe our young people and their parents nothing less.

We, the members of the legislative branch, cannot determine the need of a top physicist or those of other disciplines. We must trust others to make those decisions. We also must encourage self-initiative and entrepreneurial activity, and reward--not punish or stifle these efforts.

What was done this biennium was by the policies set by us, the policymaking branch of government.

SB 2522: A BILL for an Act to amend and reenact subsection 13 of section 4-09-01, subdivision a of subsection 1 of section 4-09-10, and subsection 2 of section 4-09-14 of the North Dakota Century Code, relating to the definition of noxious weed seeds, to seed labeling requirements, and prohibited acts.

SB 2524: A BILL for an Act to amend and reenact section 57-02-27.2 of the North Dakota Century Code, relating to consideration of irrigation in the valuation of cropland; to provide an effective date; and to provide an expiration date.
