Dear Members:

After Representative Clarence F. Martin of the 36th District passed away on Sunday, February 9, 1997, his name was removed from the House voting roll on Monday, February 10, 1997. The question was then raised about what number of votes would constitute a majority of House members to pass bills and resolutions and what number of votes would constitute a two-thirds majority of members.

I have studied the issue very thoroughly and have come to the following conclusions. Authority can be found on both sides of the question of whether "members elected" refers to an unchanging number reflecting members who received certificates of election or depends on circumstances existing at the time of the vote on an issue. There are court cases on both sides of the issue and a 1971 opinion of the Attorney General which concluded a vacancy did not mean a reduction in the number required. The North Dakota Supreme Court has not decided the issue. However, a strong argument can be made that a vacancy caused by the death of a member is not to be included in computing the number of members-elect. Section 501(1) of Mason's provides a quorum consists of the majority of the members remaining qualified after subtracting vacancies. If vacancies are not subtracted, the ability of the Legislative Assembly to declare emergency measures, take action on vetoes, and even pass bills becomes increasingly dependent on action by an official of the executive branch, who alone has the power to call special elections to fill vacancies.

I have concluded that the ruling I made earlier will stand and that there will be 49 votes required to pass bills and measures and that there will be 65 votes required to constitute a two-thirds majority as per our House Rule No. 318.
