- 1 A BILL for an Act to provide an appropriation for defraying the expenses of various state
- 2 departments and institutions; to provide for a transfer from the accumulated and undivided
- 3 profits of the Bank of North Dakota to the general fund; and to declare an emergency.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA: 4

5	SECTION 1. APPROPRIATION. There is hereby appropriated out of any n	noneys in
6	the general fund in the state treasury, not otherwise appropriated, and from special	funds
7	derived from federal funds and other income, the sums as hereinafter provided or se	o much of
8	the sums as may be necessary. These sums increase the general fund and specia	l funds
9	appropriation authority enacted by the fifty-fourth legislative assembly to the stated	departments
10	and institutions of the state of North Dakota for the purpose of defraying their expen	ses, for the
11	period beginning January 1, 1997, and ending June 30, 1997, as follows:

EXEMPTION.** The appropriation contained in subdivision 4 of section 1 of 15 this Act is not subject to the provisions of section 54-44.1-11 and any unexpended funds from 16 this appropriation are available during the biennium beginning July 1, 1997, and ending 17 June 30, 1999, for the purpose of providing state matching funds for public assistance and 18 disaster hazard mitigation. 19 **SECTION 3. TRANSFER.** If a settlement is reached with the United States department 20 of health and human services, there is hereby transferred from the accumulated and undivided 21 profits of the Bank of North Dakota to the general fund, an amount equal to the amount set forth 22 in the settlement agreement for settlement of a claim made against the state for imputed 23 interest on health professions student loan and nursing student loan program funds held by 24 various North Dakota institutions of higher learning. The amount of the transfer provided for in 25 this Act may not exceed \$296,005. The industrial commission shall transfer the amount 26 necessary for payment of the settlement agreed to into the general fund within ten days of 27 execution of an agreement between the state and the United States department of health and 28 human services or the effective date of this Act, whichever is later. In the event section 5 of this 29 Act does not become effective, the industrial commission shall transfer to the general fund the

amount necessary to pay the settlement on July 1, 1997.

1	SECTION 4. APPROPRIATION. There is hereby appropriated to the North Dakota	
2	university system out of any moneys in the general fund in the state treasury, not otherwise	
3	appropriated, the sum of \$296,005, or so much of that amount as may be necessary, to comply	
4	with the terms of a settlement agreement of claims made against the state by the United States	
5	department of health and human services for imputed interest on health professions student	
6	loan and nursing student loan program funds held by various institutions of higher learning.	
7	The North Dakota university system shall disburse the funds appropriated by this section in	
8	amounts not to exceed the amounts set forth below to the:	
9	Nursing student loan program at North Dakota state university \$ 25,888	
10	Nursing student loan program at Minot state university 42,887	
11	Health professions student loan and nursing student loan program 117,290	
12	at the university of North Dakota	
13	United States department of health and human services 109,940	
14	The state board of higher education shall disburse the amounts set forth above, or a lesser	
15	amount as required by the settlement agreement reached with the United States department of	
16	health and human services, within ten days of the date the industrial commission makes the	
17	transfer provided for in section 3 of this Act, but in any event the board shall pay the settlement	
18	on or before July 11, 1997.	
19	SECTION 5. EMERGENCY. This Act is declared to be an emergency measure.
