## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5	SECTION 1. APPROPRIATION. The funds provided in this section	on, or so much of the
6	funds as may be necessary, are hereby appropriated out of any moneys in the general fund in	
7	the state treasury, not otherwise appropriated, and from special funds derived from federal	
8	funds and other income, to the department of economic development and finance for the	
9	purpose of defraying its expenses, for the biennium beginning July 1, 1997, and ending	
10	June 30, 1999, as follows:

23	SECTION 2. TRANSFERS - ECONOMIC DEVELOPMENT FUND	S. Of the general

fund amount appropriated in section 1 of this Act, \$1,909,875 must be transferred to the North

- 1 Dakota development fund and \$1,410,380 must be transferred to the technology transfer fund.
- 2 The transfers must be in amounts and at such times as requested by the director of the office of
- 3 management and budget.

- SECTION 3. NORTH DAKOTA DEVELOPMENT FUND ALLOCATIONS. The
- 5 \$1,909,875 available in the North Dakota development fund must be dedicated for projects as
- 6 follows: forty percent businesses in rural areas, forty percent businesses in urban areas, and
- 7 twenty percent North Dakota American Indian businesses. Any unused funds in any category
- 8 may be transferred to another category during the second year of the biennium under rules
- 9 adopted by the director of the department of economic development and finance. The director
- 10 of the department of economic development and finance may reallocate up to twenty percent of
- 11 any region's available remaining balance of regional rural development revolving loan funds to
- 12 another region or regions for the biennium beginning July 1, 1997, and ending June 30, 1999.
- 13 SECTION 4. REALLOCATION OF ECONOMIC DEVELOPMENT FUNDS. The
- 14 director of the department of economic development and finance may reallocate among the
- 15 technology transfer, inc., fund and the North Dakota development fund for rural and nonrural
- development projects up to ten percent of the amounts appropriated for these purposes for the
- 17 biennium beginning July 1, 1997, and ending June 30, 1999.
- 18 SECTION 5. ECONOMIC DEVELOPMENT FUNDS WAGE REQUIREMENTS. Any
- 19 political subdivision or economic development authority may adopt a minimum wage
- 20 requirement for any new business or business expansion in which a majority of the capital is
- 21 provided by the North Dakota development fund and its own local development funds. These
- 22 wage requirements may be imposed on all or any portion of the employees and may exceed
- 23 federal minimum wage requirements.
- 24 SECTION 6. LEGISLATIVE INTENT TECHNOLOGY TRANSFER, INC. PROJECT
- 25 **FUNDS.** It is the intent of the legislative assembly that project funds be distributed by
- 26 technology transfer, inc., consistent with the mission and policies established by the technology
- 27 transfer, inc., board and that project funds be distributed, to the extent practical and efficient,
- 28 directly to businesses and individuals receiving project funding approval. Funding recipients
- 29 may use the project funds to purchase services, on a fee-for-service basis, from business and
- 30 industry development centers located on the campuses of the institutions of higher education.
