NORTH DAKOTA WORKERS COMPENSATION BUREAU 1997 LEGISLATION SUMMARY OF ACTUARIAL INFORMATION

BILL DESCRIPTION: Fraud

BILL NO: HB 1263

SUMMARY OF ACTUARIAL INFORMATION: The Workers Compensation Bureau, together with its Actuary, Glenn Evans of Pacific Actuarial Consultants, has reviewed the legislation proposed in this bill in conformance with Section 54-03-25 of the North Dakota Century Code.

Provides for the exchange of information, without charge, between the workers' compensation fraud unit and the attorney general's bureau of criminal investigation and other fraud investigatory agencies. Clarifies the duties of the fraud unit and the acts that may lead to penalties. Also provides for the possibility of discretionary mnesty periods with no more than one per year. Amnesty period cannot exceed sixty days. Provides for rewards not to exceed five thousand dollars annually to any person providing information that leads to the successful prosecution of fraud.

FISCAL IMPACT: Not quantifiable. Reduces administrative costs by disallowing another agency from billing the Bureau for services not charged to other agencies. Amnesty period and rewards offer incentives to report fraud, resulting in additional savings on cases that would otherwise not be discovered.

AMENDMENT: Proposed amendment removes language allowing the Bureau to provide rewards for workers compensation fraud; removes language exempting the Bureau from being charged fees for record checks; and adds the word deceptive to the type of conduct that misrepresents a person's disability.

No significant impact is anticipated.
