The drinking water treatment revolving loan fund is a new program funded by the U.S. Environmental Protection Agency (EPA). EPA provides an 80 percent grant to the states, and the states must provide 20 percent. It is likely that bonds would be issued for the 20 percent non-federal share. The entire amount is loaned to the cities at a low interest rate. It is estimated that \$20 million of federal funds would be received during the 1997-99 With the 20 percent non-federal requirement, the total loan program would be \$24 millon. Up to 4 percent of the total is allowed for administration including administrative oversight, establishing priorities, approving plans, providing technical assistance, and bonding. Administrative costs would be incurred by the State Water Commission, State Department of Health, and possibly the Municipal Bond Bank. We estimate the administration costs incurred by the State Water Commission would be \$200,000 per biennium (including administration costs of the Municipal Bond Bank). The costs to the State Department of Health would be about \$300,000 for the biennium.
