#### COMMUNICATION FROM GOVERNOR EDWARD T. SCHAFER

February 10, 1999

Pursuant to Article VIII, section 6 of the North Dakota Constitution, and NDCC 15-10-05, I am hereby nominating John T. Korsmo, of Fargo, North Dakota, to serve on the State Board of Higher Education, succeeding Paul F. Ebeltoft, Jr., whose term will expire June 30, 1999. This nomination is required to be made within the first 30 days of the session.

Mr. Korsmo's name was submitted in accordance with NDCC 15-10-02. He is not a graduate of any North Dakota institution of higher education and meets the requirements of NDCC Chapter 15-10. Therefore, I ask the Senate to consider confirming John T. Korsmo for this position.

I would appreciate the Senate confirming this nomination prior to its adjournment. Thank you for your consideration.

#### REPORT OF PROCEDURAL COMMITTEE

**MADAM PRESIDENT:** Your procedural **Rules Committee (Sen. St. Aubyn, Chairman)** recommends that the Senate Rules of the Fifty-sixth Legislative Assembly, as published in the 1999 Senate and House Rules and Committees book, be amended as follows:

**SECTION 1. AMENDMENT.** Subsection 3 of Senate Rule 205 is amended as follows:

3. The Sergeant-at-Arms shall clear the floor of the Senate chamber in front of the railing of all persons, except legislators, legislative employees, legislative guests, and properly identified representatives of the media, during the time period commencing sixty minutes before the Senate convenes on any legislative day and ending when the Senate recesses for that calendar day. During this period, a legislator may have only one guest on the floor ~~at a time~~ during a morning session and one guest on the floor during an afternoon session.

**SECTION 2. AMENDMENT.** Senate Rule 360 is amended as follows:

#### **360. INTRODUCTION AND ANNOUNCEMENT OF GUESTS - COURTESY OF THE SENATE.**

1. Introduction of guests in the Senate is limited to those individuals called on to address the Senate, individuals of statewide, national, or international prominence, and others in the discretion of the President. The presence of other guests in groups may be announced daily on the electronic message boards.

2. No member may have more than one guest in the morning on the floor during a session and one guest in the afternoon on the floor during a session as restricted under Senate Rule 205. The guest must be seated with the member at the time the session convenes.
3. For the purposes of this rule, the floor of the Senate is all of the first floor of the Senate chamber in front of the railing.

**NOTE:** House Rule 205(3) provides:

3. The Sergeant-at-Arms shall clear the floor of the House chamber in front of the railing of all persons, except legislators, legislative employees, legislative guests who have passes, former members of the Legislative Assembly who have passes, and properly identified representatives of the media, during the time period commencing sixty minutes before the House convenes on any legislative day and ending when the House recesses for that calendar day and from 12:00 noon until 1:00 p.m. on any legislative day. During these periods, a legislator may have only one guest per day on the floor. The Sergeant-at-Arms shall clear a designated area of the balcony of all persons, except legislative guests who have passes, during the daily session.

House Rule 360(3) and (4) provide:

3. No member may have more than one guest per day on the floor during the time period guests are restricted under House Rule 205. The guest must be seated with the member.
4. For the purposes of this rule, the floor of the House is all of the first floor of the House chamber in front of the railing.

#### REMARKS OF SHANDA DOAN, MISS RODEO NORTH DAKOTA 1999

Good afternoon Madam President and Senators. My name is Shanda Doan and I am honored to have the opportunity to greet you today. My roots with the Legislature go back to when I was two years old, crawling around in Rep. Strinden's office when I came to visit my mom at work. Two sessions ago I was here as a "Page for the Day" and in 1997 I served as a Senate Assistant Committee Clerk.

Today I'm before you wearing a different hat -- literally. This black Resistol and silver crown go with my newly attained role: Miss Rodeo North Dakota 1999. This year I have the opportunity to serve as the state's goodwill ambassador for the sport of rodeo, the western way of life, and the State of North Dakota.

Having grown up on a ranch near McKenzie that my great-great-grandfather homesteaded in 1882, I have a love of the American cowboy, North Dakota pioneers, and the spirit of independence, grit, and cooperation that they portray. So that I can relay some of that spirit to others, I am taking a leave of absence in 1999 from my studies at the University of Wyoming where I am a senior majoring in Agricultural Economics in Business in preparation for earning an advanced degree in Agricultural Law.

I will devote the next year to making hundreds of appearances both in state and nationally, attending rodeos and other events, visiting with people of all ages and from all walks of life. I recently had the distinct honor of carrying our American flag in all 23 performances of the National Western Stock Show and Rodeo in Denver. I've also been to several schools to acquaint children with the sport of rodeo and its heritage. Their eyes light up and imaginations go to work when they learn that roping calves and training wild horses are part of real ranch work.

The culmination of my reign will be when I compete in the Miss Rodeo America Pageant next December in Las Vegas. Whether I'm lucky enough to win or not, my goal for the next year is to touch as many lives as possible -- to make a positive impact and help keep our heritage alive.

The Miss Rodeo North Dakota program has a proud history. Throughout its 44 years, 14 of our titleholders have been runners-up or among the top 10 in the national pageant. One went on to be Miss Rodeo America. I'm proud to be a North Dakotan and proud to be among the ranks of these women.

You each should have received an invitation to my coronation auction and dance to be held this Sunday, February 14, at the Hotel Bismarck beginning at 6:00 p.m. I would like to personally invite and encourage you to attend and join in the celebration.

Thank you again for this opportunity to speak to you today. In closing, I would like to share with you a bit of cowboy logic that I've learned about moving cattle, leadership, and politics. When we're riding ahead of the herd, we need to take a look back every now and then to make sure the herd is still there. I hope you have a productive day and a good session. Happy trails!
