- 1 A BILL for an Act to create and enact a new section to chapter 14-09 of the North Dakota
- 2 Century Code, relating to the rights and duties of parents in child custody and visitation
- 3 proceedings; and to amend and reenact section 14-09-24 of the North Dakota Century Code,
- 4 relating to enforcement of child visitation.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 **SECTION 1.** A new section to chapter 14-09 of the North Dakota Century Code is 7 created and enacted as follows:

8	Pare	ental	custody and visitation rights and duties.
9	<u>1.</u>	Eacl	h parent of a child has the following custody and visitation rights and duties:
10		<u>a.</u>	Right to access and obtain copies of the child's educational, medical, dental,
11			religious, insurance, and other records or information.
12		<u>b.</u>	Right to attend educational conferences concerning the child. This right does
13			not require any school to hold a separate conference with each parent.
14		<u>C.</u>	Right to reasonable access to the child by written, telephonic, and electronic
15			means.
16		<u>d.</u>	Duty to inform the other parent as soon as reasonably possible of a serious
17			accident or serious illness for which the child receives health care treatment.
18			The parent shall provide to the other parent a description of the serious
19			accident or serious illness, the time of the serious accident or serious illness,
20			and the name and location of the treating health care provider.
21		<u>e.</u>	Duty to immediately inform the other parent of a change in residential
22			telephone number and address.
23		<u>f.</u>	Duty to keep the other parent informed of the name and address of the school
24			the child attends.

1	<u>2.</u>	The court shall include in an order establishing or modifying visitation the rights			
2		and duties listed in this section; however, the court may restrict or exclude any right			
3		or duty listed in this section if the order states the reason in support of the			
4		restriction or exclusion.			
5	SEC	CTION 2. AMENDMENT. Section 14-09-24 of the North Dakota Century Code is			
6	amended and reenacted as follows:				
7	14-09-24. Interference with visitation - Attorney's fees - Enforcement remedies				
8	and tools.	In any proceeding where in which child visitation is properly in dispute between the			
9	parents of a minor child, the court shall award the noncustodial parent reasonable attorney's				
10	fees and costs if the court determines there has been willful and persistent denial of visitation				
11	rights by the custodial parent with respect to the minor child. The court may use any remedy				
12	<u>that is avail</u>	able to enforce a child support order and which is appropriate to enforce visitation.
