- 1 A BILL for an Act to amend and reenact section 43-09-22 of the North Dakota Century Code,
- 2 relating to electrical installation inspections; to provide for electrician license reinstatement
- 3 requirements; to provide an expiration date; and to declare an emergency.

## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

5 **SECTION 1. AMENDMENT.** Section 43-09-22 of the 1997 Supplement to the North 6 Dakota Century Code is amended and reenacted as follows:

43-09-22. Inspection of installation - Condemnation. The board has jurisdiction

over and shall provide inspection for all electrical installations except railroad operations

located on railroad right of way. Inspectors authorized by the board may condemn installations

hazardous to life and property or may order specific corrections to be made. Inspectors may

order service thereto discontinued after notice to the owner of the property. The order is

12 subject to the owner's right of appeal to the board. No condemned installation may be

13 reconnected for service until proof has been furnished that the installation has been brought up

to the required standards. The board may charge the master electrician responsible for the

installation a fee to cover the cost of inspection. Cities may make provisions for inspection of

all electrical work done within their corporate limits. City inspectors shall register their names

with the board within ten days after their appointment.

SECTION 2. Reinstatement of electrician license - Continuing education.

19 Notwithstanding sections 43-09-15 and 43-09-15.1, any person who held an electrician's

20 <u>license under chapter 43-09 whose license was not renewed because of failure to fulfill</u>

21 <u>continuing education requirements under section 43-09-15.1 may reinstate the license if that</u>

22 person held an electrician's license in another state that regulates electrician licensure under

23 laws similar to the laws of this state or if that person was substantially involved in the electrical

24 industry during the lapse in licensure. An applicant for licensure reinstatement under this

- 1 section shall pay the reinstatement fees adopted by the board and shall participate in six hours
- 2 of continuing education as part of the application to reinstate the license. This section does not
- 3 apply to any person who took the examination under section 43-09-12 and who did not receive
- 4 <u>a passing grade</u>.
- 5 **SECTION 3. EXPIRATION DATE.** Section 2 of this Act is effective through March 31,
- 6 2000, and after that date is ineffective.
- 7 **SECTION 4. EMERGENCY.** This Act is declared to be an emergency measure.
