1 A BILL for an Act to provide an appropriation for defraying the expenses of the department of

2 corrections and rehabilitation.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4 SECTION 1. APPROPRIATION. The funds provided in this section, or so much of the 5 funds as may be necessary, are hereby appropriated out of any moneys in the general fund in 6 the state treasury, not otherwise appropriated, and from special funds derived from federal 7 funds and other income, to the department of corrections and rehabilitation for the purpose of 8 defraying the expenses of its various divisions, for the biennium beginning July 1, 1999, and 9 ending June 30, 2001, as follows: 10 Subdivision 1. 11 **CENTRAL OFFICE** 12 \$878,152 Salaries and wages 13 Operating expenses 118,682 14 26,950 Equipment 15 Total general fund appropriation \$1,023,784 16 Subdivision 2. 17 JUVENILE SERVICES 18 Salaries and wages \$9,764,955 19 Operating expenses 4,344,374 20 141,771 Equipment 21 Capital improvements 371,900 22 Grants 2,870,900 23 Delinquency prevention consortium 200,000 24 Total all funds \$17,693,900 Page No. 1 98016.0100

SECTION 2. TRANSFER AUTHORITY - BUDGET SECTION APPROVAL. Upon
 approval of the budget section, the director of the department of corrections and rehabilitation
 may transfer appropriation authority contained in the various subdivisions in section 1 of this
 Act.

SECTION 3. LINE ITEM TRANSFERS - EMERGENCY COMMISSION AND BUDGET
SECTION APPROVAL. Upon approval of the emergency commission, the director of the
department of corrections and rehabilitation may transfer between the victim services,
institutional offender services, and community offender services line items in subdivision 3 of
section 1 of this Act appropriation authority of up to ten percent of a given line item to adjust for
changing circumstances in meeting established performance measures. Any further transfers
must be approved by the budget section.
