ENGROSSED SENATE BILL NO. 2026

(At the request of the Governor)

1 A BILL for an Act making an appropriation for defraying the expenses of various state
2 departments and institutions; to amend and reenact subdivision 3 of section 1 of chapter 45 of
3 the 1997 Session Laws, relating to the department of corrections and rehabilitation
4 appropriation; and to declare an emergency.

5 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

6 **SECTION 1. APPROPRIATION.** There is hereby appropriated out of any moneys in
7 the general fund in the state treasury, not otherwise appropriated, and from special funds
8 derived from federal funds and other income, the sums as hereinafter provided or so much of
9 the sums as may be necessary. These sums increase the general fund and special funds
10 appropriation authority enacted by the fifty-fifth legislative assembly to the stated departments
11 and institutions of the state of North Dakota for the purpose of defraying their expenses, for the
12 period beginning January 1, 1999, and ending June 30, 1999, as follows.

3 **SECTION 3. EXEMPTION.** The appropriation contained in subdivision 3 of section 1 of
4 this Act is not subject to the provisions of section 54-44.1-11 and any unexpended funds from
5 this appropriation are available during the biennium beginning July 1, 1999, and ending
6 June 30, 2001, for the purpose of providing state matching funds for public assistance and
7 disaster hazard mitigation.

8 **SECTION 4. EMERGENCY.** This Act is declared to be an emergency measure.
