Minutes:

REP. M. KLEIN called the meeting to order, with one committee member absent, that being REP. GRANDE.

Not in favor or opposition:

JENNIFER CLARK, LEGISLATIVE COUNCIL

CLARK states that she would like to direct the committee to the substance of the bill.

Government relations had no specific studies this past interim. They rely on their statutory study authority. Study local government structure. Allocation of state and local revenue. The committee had concern that there was no representation on the advisory commission by the school board. The bill seems pretty simple and straight forward.

REP. M. KLEIN talks about the statutory committee, is this originally funded through some federal dollars that then went away?

CLARK replies that at one time this commission had broader duties. Also included following moneys into local governments. Last session before the moneys ran out. There is no federal requirement that this commission exist.

REP. M. KLEIN asks about its overall charter. What is it suppose to do? Do we really need it?

CLARK replies that she is not sure about the document the REP. M. KLEIN is referring to.

REP. M. KLEIN states that all the boards and commissions were to be listed in the document at hand.

REP. BRUSEGAARD states that he has a pretty good understanding of this study. He then makes a point of interest to the committee. REP. BRUSEGAARD also states that he has gotten some information from Legislative Council.

CLARK refers to the century code, and tells REP. M. KLEIN that she can direct the committee to the literature in the century code. (Reads from the century code.)

In favor:

BEV NIELSON, ND SCHOOL BOARDS ASSOC.

NIELSON states that she has enjoyed the past questions from the committee. The school boards have not had a seat on this issue since she has been affiliated with the association. The members would get bogged down in some education policy type issues, then sort of veered off of what the purpose was.

REP. M. KLEIN asks how many school districts there are in North Dakota?

NIELSON replies that there are 230.

REP. DEVLIN asks if they have ever been denied to go to the meetings?

NIELSON replies no, it is a public meeting, but they didn't always get notice of the dates, time or place.

JERRY HJELMSTEAD, ND LEAGUE OF CITIES

HJELMSTEAD states that they certainly support this bill. Local government could eventually work closer together.

REP. M. KLEIN asks if there is normal meeting scheduled?

HJELMSTEAD replies that it is the call of the chairman.

REP. DEVLIN asks if there is two representatives from the league of the cities and two representatives from the association of counties, that normally attend the meeting?

HJELMSTEAD replies that yes usually, and some do not have very good attendance.

REP. KLEMIN asks if the last interim decided to do there own agenda?

HJELMSTEAD replies that is correct, but previously it was assigned to them.

REP. HAAS asks what the budgeted amount is to take care of this advisory function in one biennium?

HJELMSTEAD replies no he is not sure.

REP. DEVLIN asks if they are paid to be on that committee?

HJELMSTEAD replies that he is not sure, maybe their travel expense is reimbursed.

REP. CLEARY states that the travel is covered.

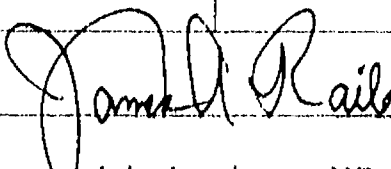

Minutes: **Chairman Krebsbach** opened the hearing on HB 1032 which relates to the membership of the advisory commission on the intergovernmental relations. **Jennifer Clark** representing the Legislative Council appeared before the committee to introduce the proposed legislation. She indicated that this bill increases the membership of the advisory commission on intergovernmental relations by one member. Currently there are eleven members. With the passage of this bill that would increase to 12 members with the newest member representing the school boards association. **Chairman Krebsbach** inquired if this was a request from the school boards association. **Ms. Clark** indicated it was. **Senator C. Nelson** inquired what this commission does. **Ms. Clark** indicated that it depends on what takes place in the interim as to what the commission does. She indicated that their duties are actually outlined in the statutes. Ms. Clark read them to the committee members. **Senator Kilzer** inquired if they deal with any foundation grants or block grants. Ms. Clark indicated that she believes they do have the authority to receive grant funds and to distribute them. **Chairman Krebsbach** inquired if there

were usually legislatively assigned studies to this committee during the interim. **Ms. Clark** indicated it varies. **Senator Kilzer** inquired if there was an appropriation for this advisory committee. **Ms. Clark** indicated that it was her understanding that for the citizen advisors of the commission are not reimbursed for their expenses. **Senator T. Mathern** indicated that this was correct. The organizations that those citizen members represent take care of the expenses. There were no further questions for Ms. Clark. **Senator T. Mathern**, district 11 appeared before the committee. He indicated he was not sure why the chairman of this committee did not come to appear before this committee. The chairman for the last interim was Senator Elroy Lindaas. While the interim committee met one of the issues that they dealt with was the allocation of tobacco funds. This just happened to be one of the topic areas. It was related to the fact that the cities had some ideas of how that money should be spent. The counties had some ideas and legislators had some ideas of course. Much of the education regarding issue like that happened in the schools. There was no one formally on this committee that represented school boards so it was kind of an interesting questions the commission had before it when the tobacco settlement really involved two levels of government but there were two levels of government not present, those two being schools and the federal government. Another thing about this commission was discussion about taxation and the laws regarding taxation. Laws on taxation affect all levels of government. Here a major taxation in our state is in regard to public schools. Here we are talking about taxation in this committee and the group that taxes the most is not on the committee. He thought it made sense that this commission have a representative of the school boards. The is not a committee that takes on a lot of action. He sees this committee as a vehicle for these entities to communicate in a formal way. He thinks that is good for the legislature, good for our state that these entities have this formal mechanism of communication and that is

what this commission does. He supports the addition of this school boards member. **Chairman Krebsbach** inquired if there was a statutorily set number of times this commission would meet. **Senator T. Mathern** indicated there was not. **Senator C. Nelson** indicated that she knows we are a rural state but the new census has come out and shows there's been a shift. She looks at the whole makeup of this committee and sees a really rural slant to it. She wonders if there is any effort made to get some sort of an even mix here. She doesn't see where the urban influence is. **Senator T. Mathern** indicated that this committee doesn't deal so much in rural vs. urban issues. It more what can be done for the state as a whole. **Jennifer Clark** indicates that there is a statutorial requirement that says the commission must meet at least two times a year. **Bev Nielson** representing the North Dakota School Boards Association appeared before the committee. She indicated the school boards association supports HB 1032. **Connie Spryncznatik** representing the North Dakota League of Cities appeared before the committee indicating they support HB 1032. **Terry Traynor**, Assistant Director of the Association of Counties, indicated that they have no problem with this bill and would welcome a member to the commission from the school boards association. There was nothing further on HB 1032. No further testimony was offered in support of, in neutral position on, or in opposition to HB 1032. **Chairman Krebsbach** closed the hearing on HB 1032. **Senator C. Nelson** moved Do Pass on HB 1032 seconded by **Senator Wardner**. Roll Call Vote indicated 6 Yeas, 0 Nays, and 0 Absent or Not Voting. **Senator T. Mathern** will carry the bill.
