Minutes: Chairman Earl Rennerfeldt, Vice Chair Jon O. Nelson, Rep. Brekke, Rep. Drovdal,

Rep. Galvin, Rep. Keiser, Rep. Klein, Rep. Nottestad, Rep. Porter, Rep. Weiler, Rep. Hanson, Rep. Kelsh, Rep. Solberg, Rep. Winrich.

Chairman Rennerfeldt: Is there anyone here to introduce this bill? Are the fish and game people coming back?

Rep. Hanson: Mr. Chairman, they have 135 people working there, I would think that they would have one person here to testify to the two bills they had here today.

<u>Vice Chair Nelson:</u> Rep. Hanson, Roger was prepared to testify on 1069, when he knew it would be recessed till next week, he said he would be back to testify on this bill.

Chairman Rennerfeldt: Let's take a five minute break.

Chairman Rennerfeldt: I will reopen the testimony on HB 1070.

Roger Rostvet - ND Game and Fish: (See written testimony)

Rep. Keiser: I looked at your chart. This is a pretty neat bill because we don't have to give any of these away. You are proposing an award for nobody. Would oppose an amendment that would perhaps move this down to 25 years of service.

Rostvet: The chart may be a little deceptive in the fact that we started certifying instructors in such a time that the original instructors are still moving in the chain. It is not that the program is ongoing from that time forward. We certainly have no opposition to moving that schedule from 30 years to whatever the committee would deem appropriate.

Rep. Porter: Mr. Rostvet. This lifetime combination license, what would it allow a person to hunt without purchasing a license. I've heard some concerns from people in regards to deer, antelope and other things that are on a separate drawing. What actually could you hunt with this license?

Rostvet: Good question. The lifetime combination license is basically your fishing, small game and general game stamp and fur bearers license. The combination license does not give any provision for any big game tags or special privileges on special lottery tags.

Rep. Hanson: What happens when you grant someone a license and he leaves the state?

Rostvet: I would have to check, Rep. Hanson. There is a provision in there for revocation of it. I would have to look that one up. Most of the time these are lifelong residents. I would have to take a look.

<u>Chairman Rennerfeldt:</u> Roger, could you explain the five year interval recognition you mentioned in your testimony.

Rostvet: The department right now has a recognition program based on five year increments for x number of years you get a jacket, for more years you get an engraved knife. If you reach 25 years, that's been our pinnacle right now, you receive your choice of a shotgun or a rifle that has a medallion placed in the stock for hunter safety recognition. This program is a monetary cost of

about \$26 to the department, it certainly isn't something that has monetary importance. These individuals have donated so much time and effort to the state of ND and the Game and Fish Department and need to be recognized in a higher level, such as the legislature.

<u>Vice Chair Nelson:</u> Roger, do you have a lifetime license of any other kind now?

Rostvet: No, this is the only lifetime license available.

<u>Vice Chair Nelson:</u> So just the logistics of this, the license will be will be issued once. For waterfowl hunting you still have to purchase a federal duck stamp, or is it something issued every year and just have the lifetime certificate. Where do you paste your stamp.

Rostvet: What we plan on doing is having an official one time award and then issuing a permanent card which they could place those stamps on, and yes, they would have to buy a federal duck stamp. That would be easier for the individual rather than reissuing them one every year.

Rep. Drovdal: Roger, looking at Sec. 2 and Sec. 3 of this bill, it appears that they just lined out Sec. 2 and created a new Sec. 3, what is the rationale behind that?

Rostvet: Which section were you referring to?

Rep. Droydal: Sect. 2 amended and then Sec. 3 puts it back into that subsection. What is the rationale behind that?

Rostvet: The Legislative Council looked at that. We have the sportsman license which is a separate license all together and we have the resident license \$1 certificate and it would seem rather silly on our part giving a lifetime sportsman license and then making them go down and buy a \$1 stamp each year. That is the intent behind it. I can double check with the Legislative Council on that, I can see where the confusion comes in, I believe that was the switch made to

cover that section. It does seem confusing. Our intent was for them not to have to pay for that \$1 certificate.

Chairman Rennerfeldt: Any other questions from the committee?

Dean Hildebrand - Dir. Of ND Game and Fish: The reason for this bill is we have a fellow in the program that has been with us for 28 years. He has received his shotgun. We don't have any means of rewarding anyone else when they reach the 30 year bracket so this is an honorary type certificate. We hope to have something frameable. We want to make this as simple as possible. You charge us with hunter safety. There is no way we could teach that without volunteers. WE have between 500 and 700 educators a year teaching about 5 to 6 thousand kids. It is becoming more difficult to get volunteers. It is hard to get kids in this program. We have a good safety record since this law went into effect. If you can help us make this happen we would appreciate it.

<u>Chairman Rennerfeldt:</u> If we amended this to 25 years instead of 30. What's your opinion on that?

Hildebrand: I don't have any big heartburn with that. We have a rifle that we give at 25 years. This is to appreciate that additional five years. IF you wanted to back it up, I appreciate the gesture, but I don't think it is necessary. I think we would follow with what we have now. We don't have a lot to offer them, so this is a gesture trying to give some prestige to the job, to keep our instructors to hang on there a bit longer. It is a labor of love. You have to prepare and work at it.

Rep. Nottestad: Going back to what he said about the amendment. Would there be any prestige or anything for you when you passed out that shotgun for 25 years and then to offer the license for something to use it with.

Hildebrand: We could, now that you got that shotgun and you are doing such a great job for us I would like you to stay five more years for us so I could give you that lifetime award. Roger mentioned if you want to do it at that time we could. I could make it retroactive for those people who have got their shotgun.

Rep. Hanson: Have you run this by the Hunter Safety Group. Do they support this?

Hildebrand: Yes, to my knowledge we have visited with the director and they know what's up and about. It is my hope to announce them if we can get this passed by next February as an incentive at the next convention.

Rep. Hanson: I have only had two contacts on this and both opposed this.

Hilldebrand: What was their rationale on this? If there is a misconception about it giving a license for deer or elk, that is not the case. This is just the basic hunting and fishing certificate.

Chairman Rennerfeldt; Any further questions?

Rep. Galvin: Before you mentioned the shotgun you give away, I was also thinking we should move it up five years, but since you are giving that award, it would mean that the 30 year award would have a little more prestige. It should be something really special. I would be in favor of leaving it the way it is.

Chairman Rennerfeldt: Any further questions?

Bill Pfeiser - ND Chapter of the Wildlife Society: (See written testimony).

Chairman Rennerfeldt: Any questions? If not thank you Bill.

Mike Donahue - ND Wildlife Federation: We support this bill and we as for a Do Pass. We appreciate the volunteer hours of these instructors. We do recommend that the committee amend the bill to give the award at the 20 year mark. There was some concern that some may not live long enough to get this award. Depending on when they start their instruction year.

Chairman Rennerfeldt; Any questions? Rep. Porter.

Rep. Porter: Just maybe a comment. Maybe a change of lifestyle is needed for those who don't think they can make it past twenty years.

Rep. Galvin: If you back it down to the 20 year level then what would you do about the shotgun award? You would be giving the certificate before the shotgun.

<u>Donahue</u>: That is correct. We still would give them the shotgun or rifle, we just think that for the cost of this certificate, we thought the state would like to support the 20 year level.

Rep. Galvin: I guess what I meant was, you would be giving the big award before the small award.

<u>Donahue</u>: That depends on the cost of the rifle or shotgun.

Chairman Rennerfeldt: Any other questions? Thank you Mike, anyone else eare to testify on this bill?

<u>Paul Crary - Cass County Wildlife Club:</u> We would like to show our favor of this bill and recommend a do pass.

<u>Diehl:</u> We teach gun safety, we teach history, we teach ethics, conservation, first aid, survival and game identification. My philosophy is we are never going to teach these kids to hunt, but as

far as proper things to do, if we walked away with respect for the landowner and the land, we have done our job. We donate 15 to 20 hours a year.

Chairman Rennerfeldt: Any other questions?

<u>Hildebrand:</u> We are getting a lot of adults coming with our kids, including females. That is gratifying to us too.

Rep. Keiser: Have you ever run the numbers on what the value of this program is to your agency?

Hildebrand: I could run that for you and it would be in the millions of dollars. You take the 500 to 700 instructors and the 6000 kids a year that your are educating and we had to pay mileage and instructor hours, heat and lights, it would be great. One of the problems is gun safety on campus and it is difficult to do that now adays, there is a liability situation with that and we need to get the best instructors we can. I can't commend the folks in ND enough for the tremendous job they do. That is why this bill is here.

Rep. Hanson: How many federal dollars do you get for this program?

Hildebrand: I can't answer that, we have an excise tax on guns and ammunition and some of those dollars come back to the state of ND. I don't have the answers but I can get that to you. It provides the infrastructure and office, we only have a couple of people that work in that program. They do a pretty good job.

Rep. Nottestad: On the federal dollars coming in, are any specified for hunter education or is that your option?

Hildebrand: No, they are specified for that.

Chairman Rennerfeldt: Is there any more testimony?

SENATOR FISCHER opened the hearing on HB 1070.

ROGER ROSTUET, representing the North Dakota Game & Fish Department the sponsor of HB1070, A BILL RELATING TO GRATIS HUNTING LICENSES FOR CERTIFIED HUNTER EDUCATION VOLUNTEER INSTRUCTORS AND RELATING TO THE CERTIFICATE FEES, testified the bill is a good bill for good people to do good things (See attached testimony).

SENATOR CHRISTMANN: asked what kind of licenses would be granted to these volunteers. ROGER ROSTUET answered that it is a sportsmen's license and does not entitle them any of the special lottery tags or any preference in the lottery tags but covers basic hunting, fishing, fur bearer and excludes the special lottery tags like turkey or deer tags.

PAUL CRARY representing the Cass County Wildlife Club testified in support of the HB 1070.

MIKE DONAHUE representing the North Dakota Wildlife Federation and the United Sportsmen of North Dakota testified in support and strongly urged passage of HB 1070.



NONTH DAKOTA HUNTER EDUCATION


INSTRUCTOR LONGEVITY PROFILE
